**Re: EB-2015-0029 –Union Gas 2015-2020 DSM Plan – SEC Cost Claim**


We are counsel for the School Energy Coalition. We enclose the cost claim of the School Energy Coalition, on the Board's form and enclosing docket details.

Jay Shepherd of our office had primary carriage of this matter, and was involved in all aspects of the proceeding. It included detailed discovery, and a lengthy hearing. A small number of hours by Mark Rubenstein to assist has not been included in the claim.

We note that this proceeding was joint with EB-2015-0049, the Enbridge 2015-2020 DSM Plan. Where it was clear that time was being spent on only one of the applications, but not the other, we have calculated the hours separately. However, for most of the proceeding the issues were intermingled, and so we have simply divided the time equally between the two applications. This is true, for example, in most of the oral hearing and final argument activities.
