IN THE MATTER OF The Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B, and in particular, s.90 thereof;

AND IN THE MATTER OF Union Gas Limited, pursuant to Section 90(1) of the Ontario Energy Board Act, requests approval from the Ontario Energy Board ("OEB") for leave to construct two natural gas pipelines in the City of Windsor in the Province of Ontario;

AFFIDAVIT OF SERVICE

I, SHELLEY BECHARD, of Municipality of Chatham-Kent, in the Province of Ontario,

MAKE OATH AND SAY:

That I am an employee in the Registered Office of Union Gas Limited and, as such, have knowledge of the matters herein deposed to.

1. On February 9, 2016, I did cause to conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.

 - d. the Métis Nations of Ontario, Lands, Resources and Consultation Office, 75 Sherbourne St., Suite 222, Toronto, Ontario M5A 2P9
 - e. all affected utilities and railway companies
 - f. members of the Ontario Pipeline Coordinating Committee

3. On February 12, 2016, I did cause to make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Union’s office and in a prominent place on Union’s website.

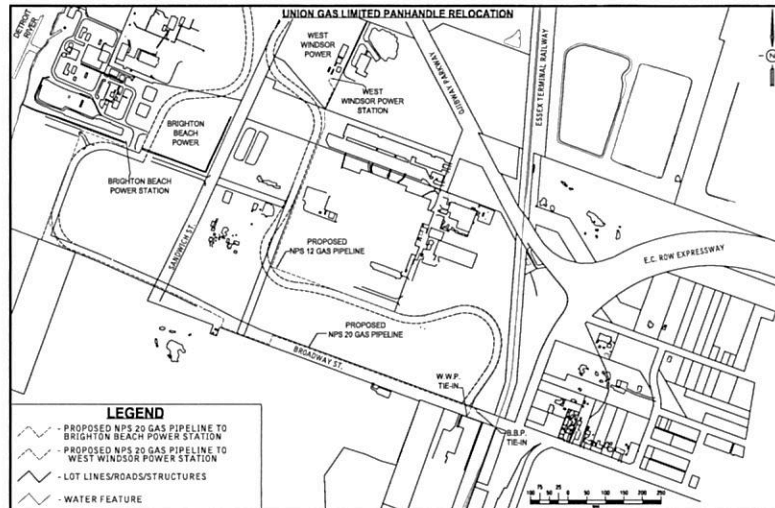

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Union. During the hearing, we will question Union on the case. We will also hear questions and arguments from individuals, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Union on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **February 29, 2016** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

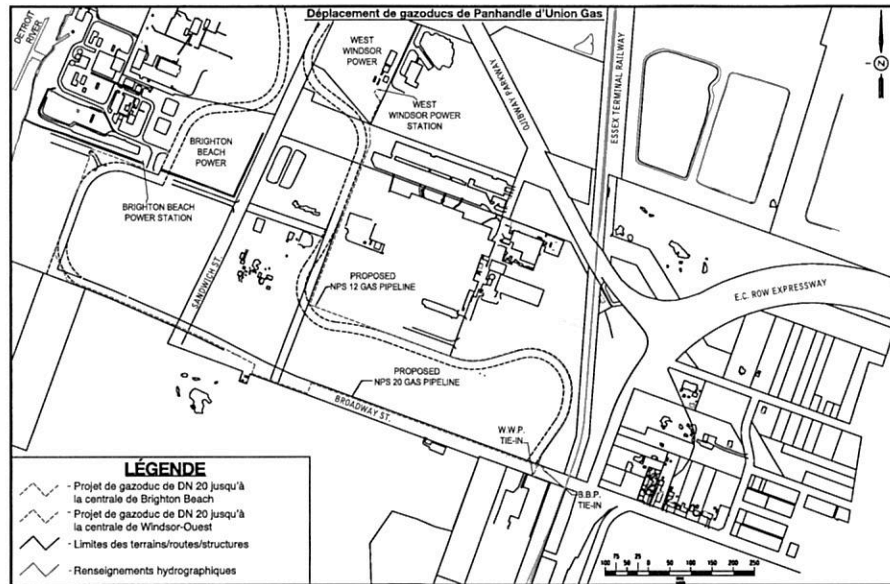
