

I, **Adrian Pye**, of the City of Toronto in the Province of Ontario, MAKE OATH AND SAY:

1. I am employed as a Senior Analyst, Regulatory Affairs, with the Independent Electricity System Operator ("IESO") and as such have knowledge of the matters hereinafter deposed to.
2. On February 17, 2016 the Ontario Energy Board ("OEB") issued the Notice of Application ("Notice") for OEB proceeding #EB-2015-0275 and by Letter of Direction directed the IESO to undertake a number of steps to provide notice through publication on its website, notification and service. Pursuant to the direction of the OEB, the IESO has published, provided notification of and served the Notice as detailed below. A copy of the Letter of Direction is attached hereto as **Exhibit "A"**. Copies of the English and French versions of the Notice are attached hereto as **Exhibits "B" and "C"** respectively.
3. The IESO has posted the English and French versions of the Notice on the IESO website on the "Corporate Reporting" page. The English version is headed with the Ontario Government logo and the words "Ontario Energy Board". The Ontario Energy Board (OEB) has now issued its Notice of Hearing for the IESO's application for approval of its 2016 revenue requirement, expenditures and fees (Notice). Please note that you must serve the Notice to the parties identified below **within fourteen days** of the date of this letter. If service is not possible within fourteen days, you must inform the Board Secretary immediately.

Further, you had requested that the IESO's draft Issues List be provided for comment along with the Notice. The OEB has decided that it will address matters related to an issues list later in the proceeding.

You are directed:

1. To arrange immediately for the service of the enclosed English and French versions of the Notice, in the exact form accompanying this letter, except:
 - a. For the English version of the Notice, under the sections entitled "**BE INFORMED AND HAVE YOUR SAY**" and "**ORAL VS. WRITTEN HEARINGS**" remove the bold and bracketed words "[insert actual date 10 calendar days from the date the notice is posted on the applicant's website]"; and

- b. For the French version of the Notice, under the sections entitled "**SOYEZ RENSEIGNÉ ET DONNEZ VOTRE OPINION**" and "**AUDIENCES ORALES ET AUDIENCES ÉCRITES**" remove the bold and bracketed words "[insérer la date correspondant à 10 jours calendaires suivant la date que l'avis est affiché sur le site web de la requérante]"; and

In each of the English and the French version of the Notice, insert the same date which shall be determined by adding 10 calendar days to the date that each of the English and French versions of the Notice will be posted on the IESO's website in accordance with the requirements of paragraph 3 below. Use the following date format "**January 1, 2014**" for the English Notice and the following date format for the French Notice "**1 janvier 2014**".
2. Once the the requirements of paragraph 1 are completed, to immediately and prior to completing any other steps required in this letter of direction, file with the OEB a pdf version of the complete (dated) Notice (Dated Notice).
3. To make a copy of both the English and French versions of the Dated Notice, the application and the evidence, and any amendments thereto, available for public review at the IESO's office and on the "Corporate Reporting" page on the IESO's website.
4. No later than the date the Dated Notice is posted on the IESO's website in accordance with paragraph 3 above, to serve a copy of each of the enclosed English and French versions of the Dated Notice and the application directly on:
 - a. all registered intervenors in OEB proceedings EB-2013-0381 and EB-2013-0326
 - b. all parties registered as IESO market participants as of the date of this letter
5. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 4 above immediately thereafter.
6. To provide a copy of the Dated Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

ONTARIO ENERGY BOARD NOTICE INDEPENDENT ELECTRICITY SYSTEM OPERATOR

The Independent Electricity System Operator has applied for approval of its 2016 revenue requirement, expenditure and fees.

Learn more. Have your say.

The Independent Electricity System Operator has applied to the Ontario Energy Board for approval of its fiscal 2016 revenue requirement, expenditure and fees to be charged effective January 1, 2016. The Independent Electricity System Operator's 2016 proposed revenue requirement, expenditure and fees are based on its 2016-2018 Business Plan that was approved by the Minister of Energy on December 9, 2015. This is the Independent Electricity System Operator's first application since its merger with the Ontario Power Authority. The Independent Electricity System Operator (IESO) is seeking the following approvals:

- A 2016 revenue requirement (excluding forecast revenue) of \$182.1 million and net revenue requirement of \$181.1 million
- An IESO usage fee of \$1.13/MWh to be paid commencing January 1, 2016 by all market participants based on energy withdrawn from the IESO-controlled grid (including scheduled exports) and embedded generation
- To discontinue the Ontario Power Authority usage fee effective January 1, 2016
- To rebate to (or charge) market participants the difference between the 2016 IESO usage fee approved by the Board and the interim usage fee or fees paid
- To retain \$10 million as an operating reserve
- To use amounts from the IESO's and the Ontario Power Authority's operating reserve and the amounts in the Registration Fees Deferral Account and the Forecast Variance Deferral to cover incurred merger costs.
- To rebate (or charge) any balance in the year-end 2015 Forecast Variance Deferral Account above the \$10 million operating reserve, based on the IESO's audited 2015 financial statements
- To continue to charge Registration Fees of up to \$10,000 per proposal for electricity supply and capacity procurements, including conservation and load management procurements
- To continue to charge a non-refundable application fee for the Feed-in-Tariff program of \$0.50/kW of proposed Contract Capacity, having a minimum of \$500 and to a maximum of \$5,000
- To continue charging the Large Renewable Procurement qualification submission fee from Request for Qualification applicants
- To continue charging \$1,000 for the IESO's market participation application fee

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The OEB will hold a public hearing to consider the IESO's requests. We will consider the evidence filed by the IESO, question the company on its proposals, and allow individuals and groups that wish to participate to provide evidence, question the company and make arguments about whether the requests should be granted. At the end of this hearing, the OEB will determine if the IESO's proposed revenue requirement, expenditure and fees are appropriate and whether the approvals sought should be granted.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the IESO's application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **February 29, 2016** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

La Société indépendante d'exploitation du réseau d'électricité a déposé une requête en vue de l'approbation de ses besoins en revenus, de ses dépenses et de ses frais pour l'année 2016.

La Société indépendante d'exploitation du réseau d'électricité a déposé une requête auprès de la Commission de l'énergie de l'Ontario (CEO) en vue d'obtenir l'approbation de ses besoins en revenus, de ses dépenses et de ses frais pour l'année 2016 à compter du 1^{er} janvier 2016. Les besoins en revenus, les dépenses et les frais proposés pour l'année 2016 par la Société indépendante d'exploitation du réseau d'électricité sont fondés sur son plan d'affaires de 2016-2018 approuvé par le ministre de l'Énergie le 9 décembre 2015. Il s'agit de la première requête déposée par la Société indépendante d'exploitation du réseau d'électricité depuis sa fusion avec l'Office de l'électricité de l'Ontario (OEO). La Société indépendante d'exploitation du réseau d'électricité (SIERE) cherche à obtenir les approbations suivantes :

- Des besoins en revenus de 182,1 millions de dollars (à l'exclusion des revenus prévus) et des besoins en revenus nets de 181,1 millions de dollars pour l'année 2016;
- Des redevances d'utilisation de 1,13 \$/MWh perçues par la SIERE à compter du 1^{er} janvier 2016 auprès de tous les intervenants du marché en tenant compte de la consommation d'énergie indiquée sur la grille tarifaire établie par la SIERE (y compris les exportations prévues) et de la production intégrée;
- Cesser l'application des redevances d'utilisation perçues par l'OEO à compter du 1^{er} janvier 2016;
- Accorder une remise aux intervenants du marché (ou facturer ces derniers) pour la différence entre les redevances d'utilisation perçues par la SIERE pour l'année 2016 approuvées par la CEO et les redevances d'utilisation intérimaires ou les frais payés;
- Conserver un montant de 10 millions de dollars comme réserve de fonctionnement;
- Utiliser les montants provenant de la réserve de fonctionnement de la SIERE et de l'OEO et les montants provenant du Compte du report des droits d'inscription et du Compte de report des variations prévues pour payer les coûts engagés liés à la fusion;
- Accorder une remise pour le solde, s'il y a lieu, du Compte de report des variations prévues de fin d'année 2015 pour une réserve de fonctionnement dépassant les 10 millions de dollars (ou facturer le solde), compte tenu des états financiers audités de la SIERE pour l'année 2015;
- Continuer de facturer des droits d'inscription allant jusqu'à 10 000 \$ par offre de service relative à l'approvisionnement en matière de consommation et de capacité d'électricité, y compris l'approvisionnement relatif à la gestion de la conservation et de la consommation;
- Continuer de facturer des frais d'application non remboursables de 0,50 \$/kW dans le cadre du Programme de tarifs de rachat garantis de la capacité proposée au contrat, soit un minimum de 500 \$ et un maximum de 5 000 \$;
- Continuer de facturer les frais de soumission d'admissibilité à l'approvisionnement de grands projets d'énergie renouvelable auprès des proposants d'une Demande de qualification ;
- Continuer de facturer un montant de 1 000 \$ en frais de demande d'intervenant du marché de la SIERE.

Business Plan and Request to Reduce IESO Fee Filed with the OEB

The IESO is requesting a nine percent reduction in its usage fee in its revenue requirement submission filed with the Ontario Energy Board on January 19. The 2016-2018 Business Plan, which reflects the annual savings of \$5 million from merging the IESO with the Ontario Power Authority, formed part of the submission.

Further efforts outlined in the plan expect to achieve savings of more than \$10 million by 2018, allowing the IESO to request a lower fee. The IESO is seeking approval of a proposed 2016 revenue requirement of \$181.1 million to be recovered through a usage fee of \$1.13 per MWh, effective January 1, 2016. This fee represents a nine percent reduction compared to the combined current IESO usage fee of \$0.803/MWh and the current Ontario Power Authority usage fee of \$0.439/MWh. The current fees were made interim effective January 1, 2016.

The IESO's three strategic themes – providing public value, building corporate resilience, and respecting and valuing our stakeholders – provided the context for its business planning. The plan outlines the IESO's focus and deliverables over the business planning period in each of its business units. Engagement initiatives and the IESO's Stakeholder Advisory Committee will continue to play an important role in providing input into the IESO's decision-making.
