**Re: Application for Amendment to Electricity Generation Licence – Transfer to Parent
Brantford Generation Inc. (EG-2008-0019)**

We are counsel for The Corporation of the City of Brantford (the “**City**”) and its indirect subsidiary Brantford generation Inc. (“**BGI**” and, together with the City, collectively, the “**Brantford Entities**”). The Brantford Entities are seeking an amendment to BGI’s Electricity Generation Licence numbered EG-2008-0019 (the “**Licence**”) to change the name listed on the Licence to that of the City to reflect the City’s planned acquisition of the electricity generation facility (together with all appurtenant undertakings and assets, collectively the “**Generation Facility**”) that is the subject of the licence.

Reason for Amendment

The City intends to acquire and hold the Generation Facility directly.

Description of the Amendment

BGI requests that:

1. the name listed on the Licence be amended to **The Corporation of the City of Brantford**;

Request to Dispose without a Hearing

We request that this proceeding be disposed of without a hearing as outlined in section 21(4)(b) of the *Ontario Energy Board Act, 1998*. Section 21(4)(b) states that the Board may dispose of a proceeding provided that:

no person, other than the applicant, appellant or licence holder will be adversely affected in a material way by the outcome of the proceeding and the applicant, appellant or licence holder has consented to disposing of a proceeding without a hearing.

The outcome of this proceeding will not adversely affect any person, including the applicant and Licence holder, since the amendment to the Licence is an administrative change, rather than a substantive change. The Brantford Entities consent to disposing of this proceeding without a hearing. The requested amendment poses no material impact to the electrical system or customers.


