Re: EB-2016-0004 – Generic Proceeding on Natural Gas Expansion

We are counsel to Anwaatin Inc. (Anwaatin) in the above-mentioned proceeding and seek your clarification of the Ontario Energy Board's (the Board) Procedural Order No. 2 dated March 16, 2016 (PO No. 2).

On February 22, 2016, Anwaatin requested intervenor status and cost eligibility in the abovementioned proceeding. In PO No. 2, the Board granted that request, but we believe may have erred in naming the First Nation in which Anwaatin is geographically located (the Mississaugas of the New Credit First Nation), but not the First Nations it represents (listed below).

We respectfully request that you update your records to reflect that Anwaatin, for and on behalf of the following First Nations, is the Board-approved intervenor that has been awarded cost eligibility:

- Aroland First Nation, and
- Waaskiinaysay Ziibi Inc. Development Corporation (WZI), which is the economic development corporation representing the five First Nations in the Lake Nipigon Watershed: Animbiigoo Zaagiigan Anishinaabek, Bingwi Neyaashi Anishinaabek, Biinjitiwaabik Zaaging Anishinaabek, Red Rock Indian Band and Whitesand First Nation (together the Combined Intervenors)

Anwaatin will, pursuant to section 8 of the Board's *Practice Direction on Cost Awards*, coordinate the Combined Intervenors and retain a consultant and legal counsel to assist in its targeted participation in the proceeding. We therefore request that you add the following persons as counsel of record and consultants for Anwaatin:
