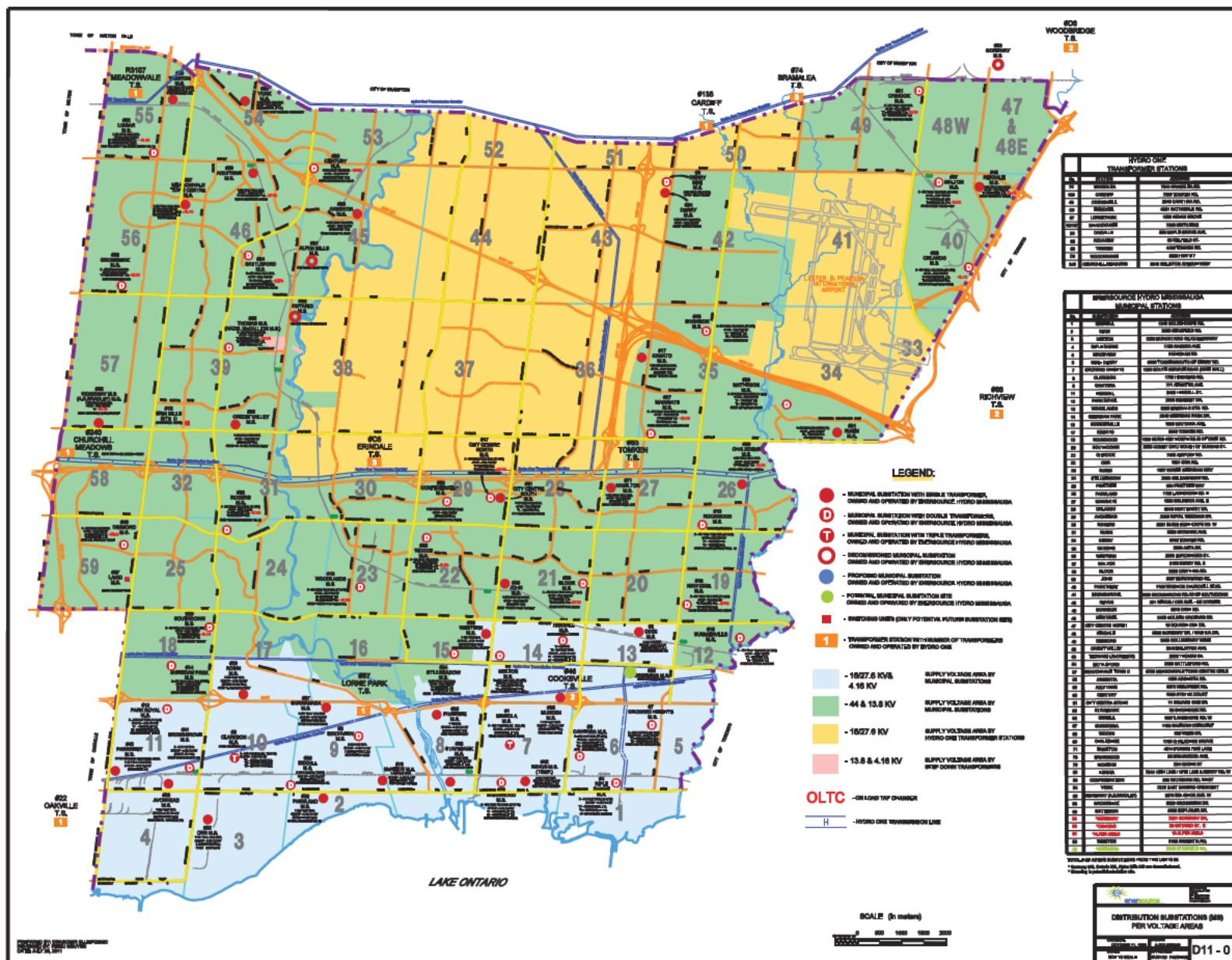

MAP OF ENERSOURCE SERVICE AREA

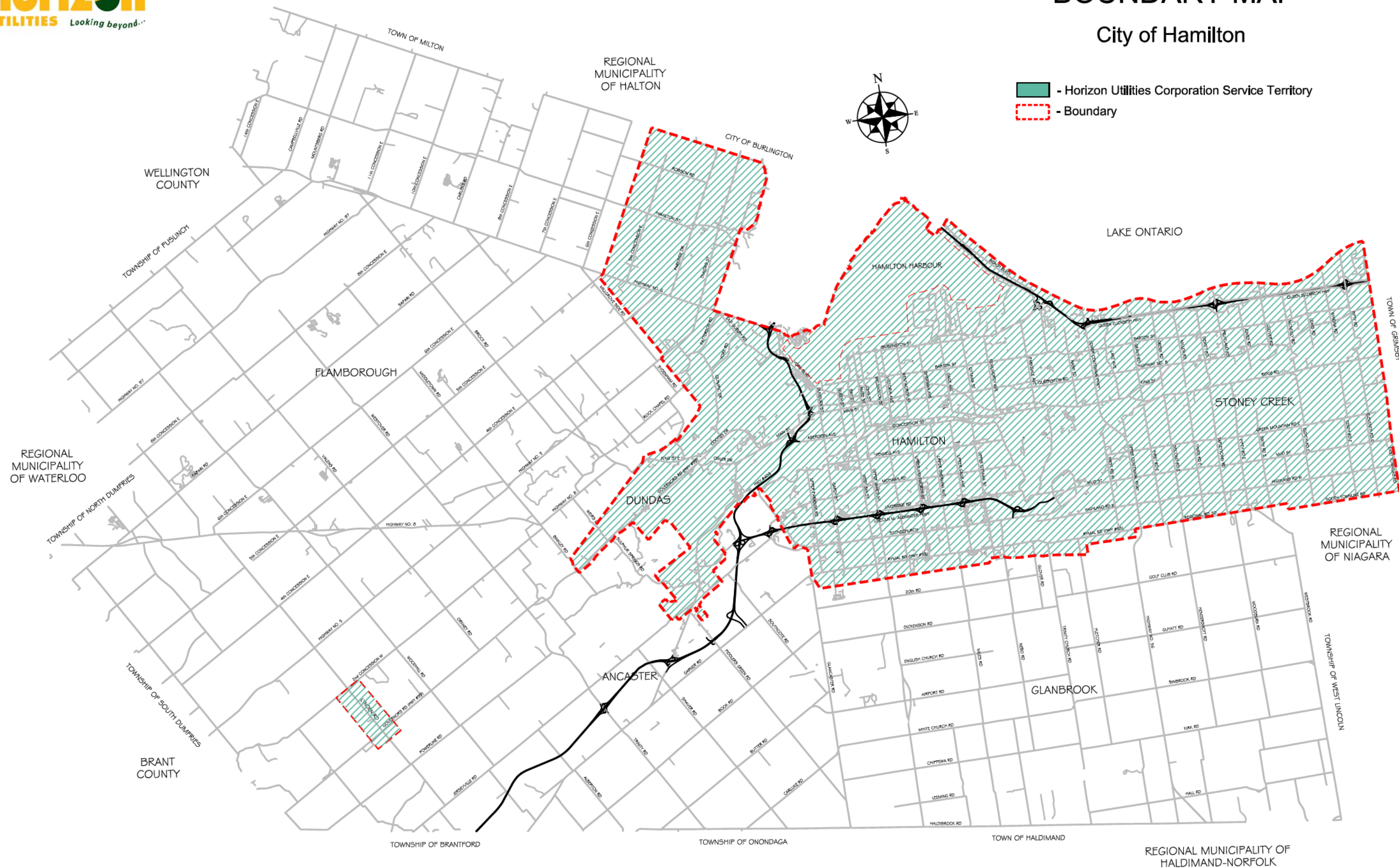


ATTACHMENT 6 MAP OF HORIZON UTILITIES SERVICE AREA



HORIZON UTILITIES CORPORATION BOUNDARY MAP

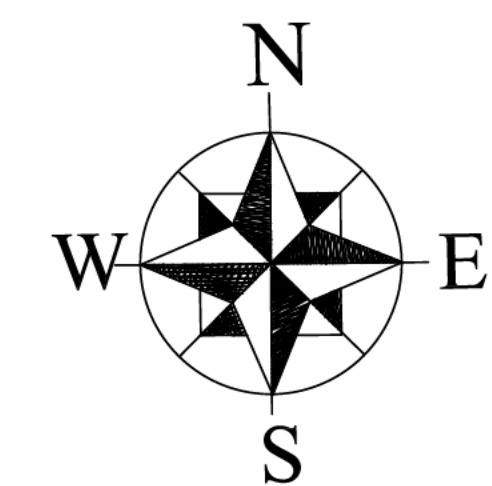
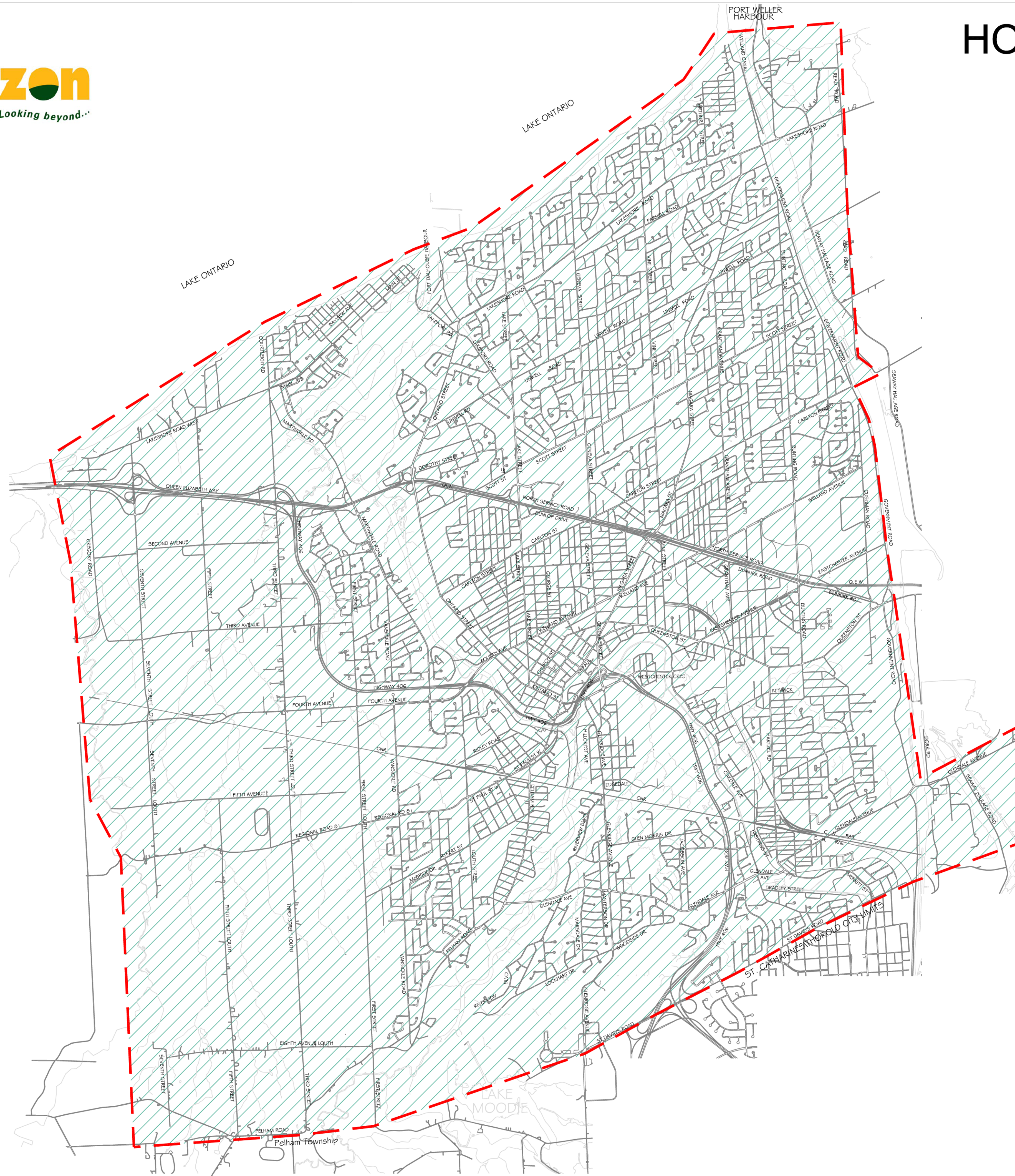
