**Enbridge Gas Distribution Inc.**

**Application for leave to construct a natural gas  
pipeline in the City of Pickering in the Regional  
Municipality of Durham**

**PROCEDURAL ORDER NO. 1**

**April 21, 2016**

Enbridge Gas Distribution Inc. (Enbridge) filed an application with the Ontario Energy Board (OEB) on March 18, 2016, in accordance with section 90 of the *Ontario Energy Board Act, 1998*, for leave to construct a natural gas pipeline and ancillary facilities to serve the Seaton Community, a new residential development in North Pickering. The proposed expansion project consists of 0.5 km of extra high pressure NPS 6 natural gas pipeline, 2.9 km of high pressure NPS 8 natural gas pipeline and ancillary facilities.

The OEB issued a Notice of Hearing on March 31, 2016. The last date for intervention was April 18, 2016. No parties applied for intervenor status.

It is necessary to make provisions for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall request any relevant information and material from Enbridge that is in addition to the evidence by written interrogatories filed with the OEB and served on all parties by **Wednesday, April 27, 2016**.
2. Enbridge shall file with the OEB complete responses to all interrogatories and deliver them to OEB staff by **Wednesday, May 11, 2016**.

3. Unless otherwise ordered by the OEB, any written submissions of OEB staff shall be filed with the OEB, and delivered to Enbridge by **Wednesday, May 25, 2016**.
4. Unless otherwise ordered by the OEB, any written reply by Enbridge shall be filed with the OEB by **Wednesday, June 8, 2016**.

All filings to the OEB must quote file number **EB-2016-0054**, be made electronically through the OEB's web portal at [www.pes.ontarioenergyboard.ca/eservice](http://www.pes.ontarioenergyboard.ca/eservice) in searchable / unrestricted PDF format. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address.
