**Application for leave to construct natural gas pipelines
in the City of Greater Sudbury**

PROCEDURAL ORDER NO. 1

April 25, 2016

Union Gas Limited (Union) filed an application with the Ontario Energy Board (the OEB) on March 11, 2016, in accordance with section 90 of the *Ontario Energy Board Act, 1998*, for leave to construct natural gas pipelines to replace two sections of the existing Sudbury lateral NPS10 Line, due to system integrity concerns and future growth requirements. The proposed expansion project consists of a total of 850 m of NPS 12 natural gas pipeline, with the first section being 700 m long and the second section 150 m long.

The OEB issued a Notice of Hearing on April 1, 2016. The last date for intervention requests was April 18, 2016.

The Industrial Gas Users Association (IGUA) applied for intervenor status and for cost eligibility. No objections were received regarding the request for intervenor status or cost eligibility.

IGUA is granted intervenor status and is eligible to apply for an award of costs. The list of parties in this proceeding is attached as Schedule A to this procedural order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. If OEB staff and IGUA require information and material from Union that is in addition to Union's evidence, and that is relevant to the hearing, they shall request it by written interrogatories filed with the OEB and delivered to Union by **Monday, May 9, 2016**.
2. Union shall file with the OEB complete responses to the interrogatories and deliver them to OEB staff and IGUA by **Tuesday, May 24, 2016**.
3. If OEB staff and IGUA wish to file evidence, they must file their evidence with the OEB and deliver it to all parties by **Monday, June 6, 2016**.
4. Parties requiring additional information related to any filed evidence, and that is relevant to the hearing, shall request it by written interrogatories filed with the OEB and delivered to all other parties by **Monday, June 20, 2016**.
5. Responses to the interrogatories on the evidence shall be filed with the OEB and delivered to all other parties by **Monday, July 4, 2016**.
6. Unless otherwise ordered by the OEB, any written submissions of OEB staff and IGUA shall be filed with the OEB, and delivered to Union by **Monday, July 18, 2016**.
7. Unless otherwise ordered by the OEB, any written reply by Union shall be filed with the OEB by **Tuesday, August 2, 2016**.

All filings to the Board must quote the file number, **EB-2016-0122** and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available, parties may email their documents to the address below.
