This letter acknowledges receipt of your application to amend electricity generation licence EG-2003-0124. The Board has assigned File Number EB-2007-0631 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application is currently incomplete and cannot be processed until the following has been filed:

- 1. Describe the intended services and markets for the new generating station. Will the power be sold into the IESO-administered market? Will be power be sold to a consumer?

- 3. Provide capital cost of the 0.7 MW hydroelectric generating station and financial arrangements.
