DECISION AND RATE ORDER May 12, 2016

Niagara Peninsula Energy Inc. (NPEI) applied to the Ontario Energy Board (OEB) to seek approval for changes to its electricity distribution rates to be effective May 1, 2016. NPEI filed a second application to dispose of a balance in the Lost Revenue Adjustment Mechanism Variance Account incurred as a result of administering conservation programs. The OEB decided that it would hold a combined hearing for the applications filed by NPEI.

The OEB granted intervenor status and cost award eligibility to the Energy Probe Research Foundation (Energy Probe) and the Vulnerable Energy Consumers Coalition (VECC).

The OEB issued a Decision and Procedural Order No. 2 on April 21, 2016 (the Decision) and directed NPEI to file a draft rate order, including a proposed Tariff of Rates and Charges.

In addition to filing the draft rate order, NPEI requested that the subaccount of account 1508 remain open, to record any further incremental costs related to the lead/lag study, including intervenor costs which have yet to be filed.

Both OEB staff and Energy Probe filed comments stating that the Tariff of Rates and Charges, provided in the draft rate order, correctly reflected the OEB's Decision. OEB staff submitted that NPEI's request to keep subaccount of account 1508 open was inconsistent with the OEB's Decision to dispose of the incremental study costs over the same time frame as the rate refund. OEB staff also submitted that the request was contrary to the OEB's standard practices, effectively requesting a true-up of actual regulatory costs for this proceeding.

In reply, NPEI submitted that OEB staff's submission was inconsistent with the OEB's 2015 cost of service decision¹ in which the deferral account was established to capture all internal and external incremental costs associated with the study to ensure NPEI was not financially affected by the OEB's directive.

Findings

The OEB approves the draft rate order and the proposed Tariff of Rates and Charges.

The OEB also approves NPEI's request to keep the deferral account open, namely 1508 Other Regulatory Assets, Subaccount Working Capital Allowance Lead-Lag Study Deferral Account.

This proceeding resulted from an OEB policy change. The OEB revised the working capital allowance default value after NPEI filed its 2015 cost of service application and evidence. The OEB established the new deferral account to capture all incremental costs, internal and external, associated with the lead-lag study. The OEB finds it appropriate for the account to remain open as yet unfiled intervenor costs, for example, are an external cost to NPEI related to the lead-lag study and this proceeding. Disposition of any future account balance requires OEB approval. As account 1508 is a Group 2 deferral account, the OEB would expect NPEI to request disposition in its next cost of service application.

Energy Probe and VECC were deemed eligible for cost awards in this proceeding. The OEB will issue a separate decision on intervenor cost claims after the following steps have been completed.

THE ONTARIO ENERGY BOARD ORDERS THAT:

- 1. The 2016 Tariff of Rates and Charges set out in Appendix A of this Rate Order is final, and will apply to electricity consumed or estimated to have been consumed on and after May 1, 2016. NPEI will notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.
- 2. Intervenors shall submit their cost claims no later than **7 days** from the date of issuance of this Final Rate Order.
- 3. NPEI shall file with the OEB and forward to intervenors any objections to the claimed costs within **17 days** from the date of issuance of this Final Rate Order.
- 4. Intervenors shall file with the OEB and forward to NPEI any responses to any objections for cost claims within **24 days** from the date of issuance of this Final Rate Order.
- 5. NPEI shall pay the OEB's costs incidental to this proceeding upon receipt of the OEB's invoice.

STREET LIGHTING SERVICE CLASSIFICATION

This classification refers to an account for roadway lighting with a Municipality, Regional Municipality, Ministry of Transportation and private roadway lighting operation, controlled by photo cells. Street lighting profile is derived through the use of a "virtual street lighting meter" that uses a street light control eye, consistent with the model type and product manufacturer of devices currently in service in the Applicant's distribution area, to simulate the exact daily conditions that the typical street light is exposed to. This simulated street light load is captured using an interval metering device, and is processed as part of the distributor's daily interval meter interrogation, validation and processing procedures. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION
