### Union Gas Limited

#### Application for leave to construct natural gas pipelines and ancillary facilities in the Municipality of Leamington

### **PROCEDURAL ORDER NO. 6**

May 25, 2016

Union Gas Limited (Union) filed an application with the Ontario Energy Board (the OEB) on January 14, 2016, in accordance with section 90 of the *Ontario Energy Board Act*, *1998*, for leave to construct a natural gas pipeline and ancillary facilities to serve the growing greenhouse market in the Municipality of Leamington. The proposed expansion project consists of 6.7 km of NPS 12 natural gas pipeline, 250 metres of NPS 16 natural gas pipeline, 60 metres of NPS 8 natural gas pipeline and ancillary facilities.

The OEB issued Procedural Order No. 5 on May 20, 2016. In Procedural Order No. 5, the OEB granted Union and Hydro One Networks Inc. (Hydro One) the opportunity to reach an agreement on the land issues prior to scheduling further procedural steps. The OEB set May 27, 2016 as the deadline for Union and Hydro One to file a letter advising whether the parties have come to an agreement on the land issues.

On May 24, 2016, the OEB received a letter from Hydro One requesting an extension to the deadline for filing a letter advising whether the parties have come to an agreement on the land issues. Hydro One requested that the deadline be extended by one-week to June 3, 2016. Hydro One stated that it has not had an opportunity to complete a thorough review of the AC Interference Report and requires additional time.

On May 25, 2016, the OEB received a letter from Union stating that it has no objection to the extension requested by Hydro One.

The OEB finds that the one-week extension requested by Hydro One is warranted and it will grant the request.

The OEB considers it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

# THE OEB ORDERS THAT:

1. Union and Hydro One shall file a letter with the OEB, and deliver the letter to all intervenors, no later than **June 3**, **2016** advising as to whether they have come to an agreement on the land issues. If the companies reach an agreement, the specifics of the agreement must be set out in the letter.

All filings to the Board must quote the file number, **EB-2016-0013** and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <u>https://www.pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>http://www.ontarioenergyboard.ca/OEB/Industry</u>. If the web portal is not available, parties may email their documents to the address below.
