PROCEDURAL ORDER NO. 3
May 31, 2016

Ottawa River Power Corporation (Ottawa River Power) filed an application (the Application) with the Ontario Energy Board (OEB) on October 5, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Ottawa River Power charges for electricity distribution, to be effective May 1, 2016.

The OEB issued its Decision and Order on the Application on May 12, 2016 and established dates for a draft rate order process for the OEB to determine a final tariff of rates and charges. On May 27, 2016, Ottawa River Power sought permission to file a revised draft rate order on June 3, 2016 and vary the dates for the draft rate order process previously established.

The OEB grants this request.

Ottawa River Power was ordered by the OEB to calculate a forgone revenue rate rider given the approved effective date of May 1, 2016 and implementation date of June 1, 2016. To accommodate the extension of the draft rate order process, Ottawa River Power shall re-calculate the foregone revenue rate riders over a two-month period to allow for an implementation date of July 1, 2016.

The OEB considers it necessary to make provision for the following matters related to this proceeding.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. Ottawa River Power shall file with the OEB and shall also forward to intervenors a revised draft rate order attaching a proposed Tariff of Rates and Charges, reflecting the OEB's findings in the Decision and Order and this Procedural Order, on or before **June 3, 2016**. The draft rate order shall also include customer rate impacts and detailed supporting information showing the calculation of final rates.
2. Intervenors and OEB staff shall file any comments on the draft rate order with the OEB, and forward to Ottawa River Power, on or before **June 10, 2016**.
3. Ottawa River Power shall file its reply submission on the comments received on or before **June 17, 2016**.

All filings to the OEB must quote the file number, EB-2014-0105, be made through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
