Re: EnWin Utilities Ltd. - Application for Service Area Amendment (Licence ED-2002-0527)

We are counsel to EnWin Utilities Ltd. ("EnWin"). EnWin is a licensed electricity distributor in Ontario, which serves the City of Windsor under licence no. ED-2002-0527 (the "Distribution Licence"). On behalf of EnWin, we are hereby applying to the Ontario Energy Board (the "Board") for an amendment to the definition of EnWin's service area, as described at Schedule 1 of the Distribution Licence.

The purpose of this application, which has been prepared in accordance with the Board's *Filing Requirements for Service Area Amendment Applications* (March 12, 2007), is to include within EnWin's service area a portion of a property that is currently located within the service area of Hydro One Networks Inc. ("Hydro One"). This will enable the portion of the property, which is now unserviced, to be served by EnWin rather than by Hydro One. This application is brought with the consent of Hydro One, as well as the relevant customer and the relevant landowner.

As contemplated by the Filing Requirements, EnWin requests that the Board proceed with this consent Application on an expedited basis.

Service Area Amendment Application EnWin Utilities Ltd.

June 2, 2016

1.0 INTRODUCTION

EnWin Utilities Ltd. ("EnWin") is a licensed electricity distributor (ED-2002-0527) that serves the City of Windsor. EnWin is filing this service area amendment application (the "Application") with the Ontario Energy Board (the "Board") for the purpose of connecting a customer that is currently developing a property located within the service area of Hydro One Networks Inc. ("Hydro One"), as such service area is described in Hydro One's electricity distribution licence ED-2003-0043. The Application is made with the consent of Hydro One, the relevant customer and the owner of the relevant property.

The customer is Windsor Solar GP on behalf of Windsor Solar LP ("Windsor Solar"). Windsor Solar is developing a solar energy generation facility on a leased portion of the Winsor International Airport property. The Windsor International Airport and associated lands are owned by the City of Windsor and the airport is operated by Your Quick Gateway (Windsor) Inc. under a long-term management contract. Electricity generated by Windsor Solar's facility will be delivered directly to Hydro One's transmission system. However, Windsor Solar's facility also requires station service for an operations and maintenance building to be constructed at the project site.

Although the Windsor International Airport is located within the City of Windsor, Schedule 1 of EnWin's distribution licence defines EnWin's service area as being "the City of Windsor as of December 31, 2002". As of that date, the Windsor International Airport property was not located within the City of Windsor but, rather, was part of Tecumseh and as such forms part of Hydro One's service area.

Windsor Solar's planned operations and maintenance building will be in the northeast corner of the project site, in close proximity to existing EnWin distribution facilities. There are no Hydro One distribution facilities near this location. Consequently, it would be more cost effective and technically simpler to serve the customer's building from EnWin's system than from Hydro One's system. As described in this Application, the requested service area amendment applies only to the portion of the Windsor Solar project site on which the operations and maintenance building is to be situated. The balance of the Windsor Solar project site, and the Windsor International Airport lands generally, would remain within Hydro One's service area.

Due to Windsor Solar's planned construction schedule for its renewable energy generation facility, and commitments it has under its supply contract with the IESO, EnWin respectfully requests that the Board consider this Application on an expedited basis. EnWin notes that the Board's *Filing Requirements for Service Area Amendment Applications* contemplates the use of an expedited process for applications brought with the consent of all affected parties.

No other distributors are affected by the Application.

2.2 Reasons for Amendment and Identification of Load Transfers

Windsor Solar is developing a solar energy generation facility on a leased portion of the Windsor International Airport property. The facility requires station service for an operations and maintenance building to be constructed at the northeast corner of the project site. Although the Windsor International Airport property is situated within Hydro One's service area, there are no Hydro One distribution facilities in close proximity to the planned site of the operations and maintenance building. However, the site is situated along the boundary to EnWin's service area and EnWin has an existing express feeder segment (not currently servicing any customers) in an easement on the Windsor International Airport property and very close to the customer's planned building.

There are no load transfers being eliminated as a result of this proposal.

2.3 Description of Proposed Service Area

The lands that are the subject of this Application are located near the northeast corner of the Windsor International Airport property, which is located at 6000 County Rd 42 in the City of Windsor, N8N 2M1. More particularly, the subject lands consist of:

• Part of PIN 01408-2026(LT) designated as part of Part 7 on Plan 12R24449, City of Windsor, as shown on the sketches provided at Attachments 'A' and 'B'.

Attachment 'C' shows an aerial image of the location of the subject area in relation to the airport and its surrounds.

2.5 Description of Proposed Physical Connection

The proposed physical connection consists of one individual General Service connection (120/208V – 200 Amps service). The point of connection will be at Pole #20080824 on EnWin's existing line 56M6, which is just west of Lauzon Parkway. At this point of connection, EnWin would install three overhead transformers. The customer will install an approximately 100 meter underground service line from its operations and maintenance building to the point of connection.

2.6 Description of Applicant's Plans for Similar Expansions in Adjacent Lands

EnWin has no plans for similar expansions on adjacent lands.

3.0 EFFICIENT RATIONALIZATION OF THE DISTRIBUTION SYSTEM

3.1 Economic and Engineering Efficiency

The Applicant is advised by Hydro One that Hydro One reviewed the customer's requirements and found that the closest connection point to Hydro One's distribution facilities would be on Lauzon Parkway at Service Road, approximately 1 km away. Hydro One has estimated that the cost to connect to Hydro One's distribution system at that location would be approximately \$200K. Since EnWin's distribution system is adjacent to and immediately to the north of the subject area, Hydro One determined that it would not be cost effective for Hydro One to expand its distribution facilities to serve this customer. Therefore, Hydro One has consented to EnWin serving this customer.

4.0 IMPACTS ARISING FROM THE PROPOSED AMENDMENT

4.1 Affected Customers and Landowners

The only affected customer is Windsor Solar and the only affected landowner is the City of Windsor as the owner of the Windsor International Airport lands.

4.2 Impacts on Customers in Subject Area

There are no other customers in the subject area.

4.3 Impacts on Customers Outside of Subject Area

There will be no impacts on customers outside of the subject area.

4.4 Impacts on Affected Distributors

There will be no material impacts on EnWin or Hydro One, or any other distributor.

4.5 Stranded or Redundant Assets

There will be no stranded or redundant assets.

4.6 Assets to be Transferred

No assets will be transferred.

4.7 Customers to be Transferred

No customers will be transferred.

4.8 Load Transfers or Retail Points of Supply to be Eliminated

No load transfers or retail points of supply would be eliminated.

4.9 Load Transfers or Retail Points of Supply to be Created

No load transfers or retail points of supply would be created.

4.10 Confirmation that Affected Persons Notified of Proposed Amendment

EnWin has informed the customer and the landowner of the Application. The customer was included in communications between EnWin and Hydro One. See responses to 4.11 and 4.12.

4.12 Customer, Developer and Landowner Consent to Application

5.1 Statement of Customer Preference

As indicated in Attachment 'E', the customer's preference is to be served by EnWin.

6.0 ADDITIONAL INFORMATION REQUIREMENTS FOR CONTESTED APPLICATIONS

Not applicable. This section of the Filing Requirements does not need to be completed where the application is brought on the consent of affected persons.

7.0 METHOD OF DISPOSITION

EnWin requests that this Application be disposed of without a hearing, in accordance with subsection 21(4) of the *Ontario Energy Board Act*, 1998.

Due to Windsor Solar's planned construction schedule for its renewable energy generation facility, and commitments it has under its supply contract with the IESO, EnWin respectfully requests that the Board consider this Application on an expedited basis. EnWin notes that the Board's *Filing Requirements for Service Area Amendment Applications* contemplates the use of an expedited process for applications, such as the present Application, which are brought with the consent of all affected parties. As such, in the Applicant's view it would be appropriate for the Application to be decided on an expedited basis without a hearing by a delegated authority, consistent with prior applications that have been made to the Board of a similar nature.

8.0 CONCLUSION

The Application and supporting evidence demonstrates that it would be economically efficient for EnWin, and not Hydro One, to serve the customer's facilities. This approach would optimize the use of existing infrastructure forming part of EnWin's distribution system and minimize the need for construction of new facilities. Consequently, it is a more cost-effective approach for the affected customer. Hydro One and the customer approached EnWin to supply service to the customer. EnWin has sufficient capacity on its existing distribution facilities immediately adjacent to the customer's site. Approval of the Application would also avoid the need for Hydro One to construct significant new facilities, at a substantial cost, to connect the customer. The Application seeks to transfer from Hydro One's service area to EnWin's service area only the area necessary to give effect to the above services and otherwise does not impact on Hydro One's service to the Windsor International Airport lands.




