We, together with Aird & Berlis LLP, are counsel to the Applicants in the above-captioned matter. In some cases, those names and addresses may constitute personal information under the *Freedom of Information and Protection of Privacy Act* and the *Municipal Freedom of Information and Protection of Privacy Act*. Moreover, the Applicants do not have the consent of the property owners to the disclosure of their identities or the addresses of the installations. More generally, though, the Applicants submit that identities of the property owners and the specific addresses of the installations are not relevant to this proceeding. The municipalities in which the generation facilities are located, as well as the

contract numbers and capacities of the facilities, remain disclosed in the public versions of these documents.
