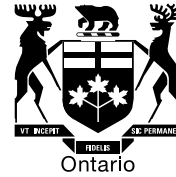

REVISED LETTER OF DIRECTION

Dear Ms. Henderson:

**Re: Hydro One Networks Inc.
2017 and 2018 Transmission Cost of Service Application
Board File Number EB-2016-0160**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing (Notice) for Hydro One's application for 2017 and 2018 Transmission Revenue Requirement and to change the Ontario Uniform Transmission Rates. The Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 and 2 below **prior to July 12, 2016**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Board Secretary immediately.

You are directed:

1. No later than the date the Notice is posted on Hydro One's website in accordance with paragraph 2, to arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on the electricity distributors and other transmission customers served by Hydro One Networks Transmission; on all licenced transmitters in Ontario, and on all intervenors of record in the previous transmission rate application proceeding EB-2014-0140.
2. To make a copy of both the English and French versions of the Notice, the

application and evidence, and any amendments thereto, available for public review at Hydro One's office and in a prominent place on Hydro One's website.

3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
