Union Gas Limited (Union Gas) applied to the Ontario Energy Board (OEB) under s. 90(1) of the *Ontario Energy Board Act, 1998* for Panhandle Reinforcement Project to construct a natural gas pipeline in the Township of Dawn Euphemia, the Township of St. Clair and the Municipality of Chatham-Kent. Union Gas also applied to recover the costs of the pipeline.

The OEB has issued a Notice of Hearing for Union Gas' application. The English and French versions of the Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. No later than the date the Notice is posted on Union Gas' website in accordance with paragraph 3, to arrange for the service of both the English and French versions of the enclosed Notice, in the exact forms accompanying this letter, and the application and the evidence, directly on each of the following:
 - a. all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above
 - b. the clerks of the Township of Dawn Euphemia, the Township of St. Clair and the Municipality of Chatham-Kent
 - c. all Aboriginal communities that have been consulted or with lands or interest in the lands directly affected by the proposed pipeline and related facilities
 - d. the Métis Nations of Ontario, Lands, Resources and Consultation Office, 75 Sherbourne St., Suite 222, Toronto, Ontario M5A 2P9
 - e. all affected utilities and railway companies
 - f. members of the Ontario Pipeline Coordinating Committee
- 3. To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at Union Gas' office and in a prominent place on Union Gas' website.
- 4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1, 2 and 3 above, immediately thereafter.
- 5. To provide a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
