We are counsel to Grimsby Power Inc. ("Grimsby Power"), the Applicant in the above-captioned matter, and we are writing to you today to address the composition and order of the Grimsby Power witness panels, and the matters to be addressed in the oral hearing.

The oral hearing in this proceeding is scheduled to begin on Wednesday, July 13, 2016. In Procedural Order No. 2, which established the July 13th hearing date, the Board indicated that the oral hearing would be held to hear the settlement proposal and the unsettled issues. The settlement proposal, filed on June 24, 2016, indicated that the issues related to OM&A and PILs were not settled, nor was the effective date for Grimsby Power's 2016 rates.

Grimsby Power intends to put forward two witness panels. Grimsby Power suggests that it would be more efficient to deal with the PILs and OM&A issues separately, and Grimsby Power is prepared to deal with the PILs issue first to accommodate the availability of intervenor representatives. Grimsby Power will present the following witnesses on the PILs panel:

- Doug Curtiss, CEO, Grimsby Power
- Mioara Domakos, Director of Finance, Grimsby Power; and
- Amy LaSelva, Finance and Regulatory Analyst, Grimsby Power
- Michel Picard, Accounting Advisory Partner Power and Utilities Practice, KPMG LLP

Copies of the Grimsby Power staff CVs accompany this letter, and copies of the CV package will be provided for identification as an exhibit at the commencement of the hearing. Mr. Picard's CV was included with his report on the rate setting implications for Grimsby Power of tax loss carry forwards (filed with Grimsby Power's evidence update on June 29, 2016, and assigned Exhibit No. KT1.1 at last week's Technical Conference). Accompanying this letter is a copy of a presentation prepared by Mr. Picard that will be used during examination-in-chief on the PILs issue.

The OM&A panel (which will also be responsible for the effective date issue) will consist of the three Grimsby Power representatives listed above. We expect that the examination-in-chief for each of the PILs and OM&A/effective date panels will be no more than 30 minutes.
