Grimsby Power Inc.

**Application for electricity distribution rates
beginning May 1, 2016**

**INTERIM RATE ORDER
and
PROCEDURAL ORDER NO. 3
July 15, 2016**

Grimsby Power Inc. (Grimsby Power) filed a complete cost of service application with the Ontario Energy Board (OEB) on December 23, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Grimsby Power charges for electricity distribution, to be effective May 1, 2016.

The OEB held a settlement conference on May 24, 25 and 26, 2016. Parties reached a partial settlement and filed a settlement proposal with the OEB on June 24, 2016. The OEB held an oral hearing on July 13 and 14, 2016 to hear a presentation on the settlement proposal and to examine the unsettled issues.

The OEB considers it necessary to make provision for the following matters related to this proceeding.

IT IS THEREFORE ORDERED THAT:

1. Grimsby Power's current approved distribution rates are declared interim as of July 14, 2016.
2. Grimsby Power shall file its responses to transcript undertakings with the OEB and forward to Board staff and intervenors on or before July 21, 2016

3. Board staff and intervenors shall file their submissions on the unsettled issues with the OEB and forward to Grimsby Power on or before July 29, 2016.
4. Grimsby Power shall file its reply submission with the OEB on or before August 9, 2016.

All filings to the OEB must quote the file number, EB-2015-0072, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
