ONTARIO ENERGY BOARD NOTICE

Union Gas Limited has applied for approval to construct a natural gas pipeline in the Township of Dawn Euphemia, the Township of St. Clair and the Municipality of Chatham-Kent. Union Gas also applied to recover the costs of the pipeline.

Union Gas Limited applied to the Ontario Energy Board for approval to construct 40 km of 36 inch diameter pipeline to reinforce the Panhandle Pipeline System in the Township of Dawn Euphemia, the Township of St. Clair and the Municipality of Chatham-Kent. Construction involves removing the existing 16 inch diameter pipeline and replacing it with 36 inch diameter pipeline. Union Gas Limited also applied for approval to recover the cost of constructing the pipeline which is estimated to be \$264.5 million.

A map of the proposed pipeline project is provided below.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Union Gas. During the hearing, we will question Union Gas on the case. We will also hear questions and arguments from individuals, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of Union Gas' application, the OEB will assess Union Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

The OEB will also assess whether the duty to consult with Aboriginal Peoples potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Union Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **August 2, 2016** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

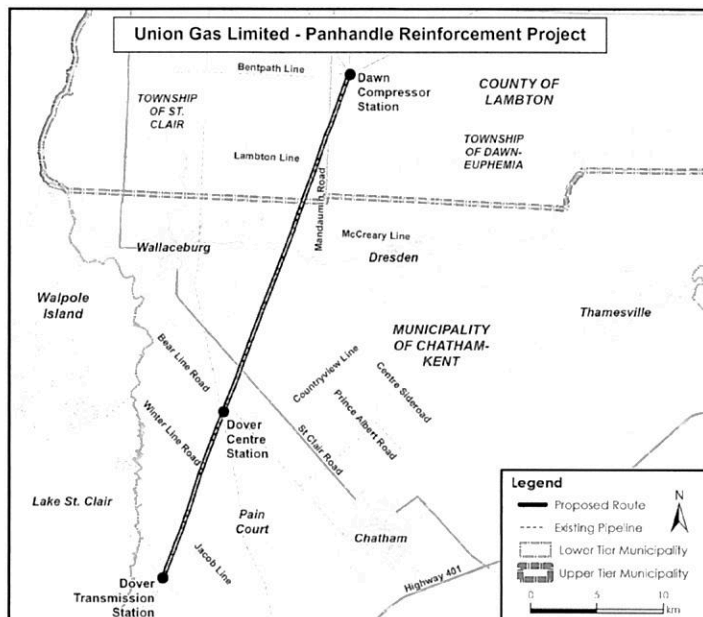
ORAL VS. WRITTEN HEARINGS

If you apply to become an intervenor, all information will be public.

Union Gas Limited a demandé l'autorisation de construire un gazoduc passant par le canton de Dawn Euphemia, le canton de St. Clair et la municipalité de Chatham-Kent. Union Gas Limited a également déposé une demande en vue de recouvrer les frais du gazoduc.

Apprenez-en plus. Donnez votre avis.

Union Gas Limited a demandé à la Commission de l'énergie de l'Ontario l'autorisation de construire un gazoduc de 40 km de long et de 91,4 cm (36 po) de diamètre, destiné à augmenter la capacité du système Panhandle existant, qui passe par le canton de Dawn Euphemia, le canton de St. Clair et la municipalité de Chatham-Kent. Dans le cadre du projet, le gazoduc existant de 40,6 cm (16 po) de diamètre serait retiré et remplacé par un autre de 91,4 cm (36 po) de diamètre. La société Union Gas Limited a également demandé l'autorisation de recouvrer les frais de construction du gazoduc, qui sont estimés à 264,5 millions de dollars.

LA COMMISSION DE L'ÉNERGIE DE L'ONTARIO VA TENIR UNE AUDIENCE PUBLIQUE

La Commission de l'énergie de l'Ontario (CEO) tiendra une audience publique afin d'étudier la demande déposée par Union Gas. Au cours de l'audience, des questions seront posées sur le projet à Union Gas. 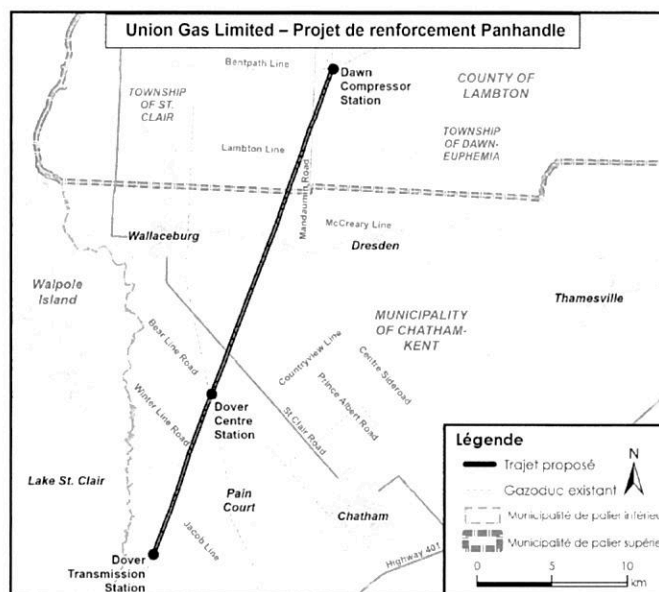
AUDIENCES ORALES ET AUDIENCES ÉCRITES

AND IN THE MATTER OF an Application by Union Gas Limited for an Order or Orders for approval of recovery of the cost consequences of all facilities associated with the development of the proposed Panhandle Reinforcement Pipeline Project.

UNION GAS LIMITED

1. Union Gas Limited (the “Applicant” or “Union”) hereby applies to the Ontario Energy Board (the “Board”), pursuant to Section 90(1) of the Act, for an Order or Orders granting leave to construct approximately 40 kilometres of NPS 36 pipeline from Union’s Dawn Compressor Station in the Township of Dawn-Euphemia to its Dover Transmission Station located in the Municipality of Chatham-Kent (“the Proposed Pipeline or the Project”).
2. The Applicant also hereby applies to the Board, pursuant to Section 36 of the Act, for an Order or Orders granting:
 - a) approval of recovery of the cost consequences of all facilities associated with the development of the Proposed Pipeline from ratepayers in accordance with the Board-approved Capital Pass-through criteria forming part of Union’s 2014-2018 Incentive Regulation Mechanism (EB-2013-0202); and,

- b) approval to calculate the revenue requirement and resulting rates of the Project based on a 20-year depreciation term; and,
 - c) approval of an accounting order to establish the Panhandle Reinforcement Project Deferral Account.
3. A map showing the general location of the Proposed Pipeline, and associated facilities and the municipalities, and highways through, under, over, upon or across which the pipeline will pass is presented at Schedule A.
4. The parties affected by this Application are the owners of lands, government agencies and municipalities over which the pipeline will be constructed, and Union's distribution customers with respect to quality of service and security of supply. The persons affected by this Application are the customers resident or located in the Municipalities, the First Nation Reserves and Métis organizations served by Union, together with those to whom Union sells gas, or on whose behalf Union distributes, transmits or stores gas. It is impractical to set out in this Application the names and addresses of such persons because they are too numerous.
5. The Applicant now therefore applies to the Board for an Order or Orders for approval of recovery of the cost consequences and granting leave to construct the Proposed Pipeline as described above.
