2016 Expenditure and Revenue Requirement Submission

The Independent Electricity System Operator (“IESO”) is writing to file responses to interrogatories (“IRRs”) in accordance with the Ontario Energy Board’s (“Board”) Decision on Issues List and Procedural Order No. 3 dated June 17, 2016. The IRRs have been filed by issue as outlined in the Board’s Decision on Issues List.

The IESO wishes to note that a number of the interrogatories have raised issues which the IESO believes to be beyond the scope of this proceeding. The IESO has, in these cases, provided responses in an effort to be of assistance to the parties. The fact that the IESO has provided an answer to these interrogatories should not be taken as any indication that the IESO considers these areas of enquiry to be appropriate for the revenue requirement proceeding.

The IESO also wishes to note that it has assigned issues for interrogatories received from CME and BOMA in cases where the issue was missing or did not appear to be accurate.

The IESO has included an updated exhibit list in its filing that itemizes the IRRs. The updated exhibit list and the chart below help to illustrate how the IRRs have been organized. The Tab of each interrogatory response refers to the issue, while the Schedule numbers have been assigned to intervenors and corresponding interrogatory numbers as follows:
