NOTICE OF INTERVENTION OF THE QUINTE MANUFACTURERS ASSOCIATION

Intervenor Background

The Quinte Manufacturers Association ("QMA") is an organization of major companies with significant manufacturing and processing operations located in the greater Bay of Quinte region which includes the cities of Belleville and Quinte West.

Statement of Interest

The QMA is very concerned with Ontario Power Generation Inc.'s ("OPG") Application and intends to actively participate in the above-noted proceeding. Members of the QMA are major consumers of electricity and some of the largest employers in the Bay of Quinte region.
