In response to the Letter of Direction, the Company advises as follows:



Application for Gas Marketer Licence & Electricity Retailer Licence**

The Application

XOOM Energy ONT, ULC filed two applications on July 18, 2016 with the Ontario Energy Board (the "OEB") under section 50 and section 60 of the *Ontario Energy Board Act, 1998*, (the "Act") for a Gas Marketer licence and an Electricity Retailer licence, respectively. The granting of these licences would enable the applicant to market natural gas and retail electricity in Ontario.

The applications will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the Act. The OEB does not intend to provide for an award of costs when deciding the applications.

La requête

XOOM Energy ONT, ULC a déposé deux requêtes datées le 18 juillet 2016 auprès de la Commission de l'énergie de l'Ontario (la « CEO ») en vertu des articles 50 et 60 de la *Loi de 1998 sur la Commission de l'énergie de l'Ontario* (la « Loi ») en vue d'obtenir, respectivement, un permis d'agent de commercialisation de gaz et un permis de détaillant d'électricité.
