
Union Gas Limited has applied to the Ontario Energy Board for approval to replace a section of 10 inch diameter natural gas pipeline with 1955 metres of 12 inch diameter pipeline and to replace an 854 metre section of 12 inch diameter natural gas pipeline in the City of Greater Sudbury. This work will facilitate the construction of a four-lane extension of Maley Drive in the City of Greater Sudbury.

A map of the proposed pipeline project is provided.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Union Gas. During the hearing, we will question Union Gas on the case. We will also hear questions and arguments from individuals, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Union Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.



The OEB will also assess whether the duty to consult with Aboriginal Peoples potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- · You can review the application filed by Union Gas on the OEB's website now.
- · You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by September 6, 2016 or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
