**RE: Request for amendment to Electricity Generation Licence EG-2008-0319 and cancellation of Electricity Generation Licence EG-2011-0419 effective October 1, 2016**

Dear Sir or Madam,

Please find this letter in respect of the above-noted Electricity Generation Licences for two solar facilities, Amherstburg Solar Park Site A and Amherstburg Solar Park Site B. The facilities are owned by Helios Solar Star A-1 Partnership (“Helios”), which is a wholly owned subsidiary of Capstone Power Corp. SunPower Energy Systems Canada Corporation (“SunPower”) is currently the licenced Operator of both facilities, as summarized below:

This letter is to provide notification that as of **October 1, 2016**, we intend to alter our arrangement with SunPower such that Helios will take over responsibility for facilities operation (i.e., assume Owner-Operator responsibility). Accordingly, we are hereby requesting that Schedule 1 of EG-2008-0319 be amended to change “operation” to “ownership and operation” of both facilities listed, with an effective date of October 1, 2016. Concurrently, SunPower is requesting that licence EG-2011-0419 be cancelled, also effective October 1, 2016; please find enclosed a signed termination request letter from SunPower.

The October 1, 2016 date is significant as this is the date that the current on-site operator, who is currently a SunPower employee, will become an employee of the Helios. We recognize the relatively short notice, so we kindly ask that you please provide written confirmation by September 15, 2016 as to whether or not OEB will be able to process our requests by this time. In the event that the amendment cannot be completed by October 1, we will consider alternate arrangements, including a deferred transition date.
