# Kingston Hydro Corporation has applied to raise its electricity distribution rates.

Kingston Hydro Corporation has applied to the Ontario Energy Board to increase the amount it charges by approximately \$2.66 each month for the typical residential customer beginning on January 1, 2017. Other customers, including businesses, may be affected as well.

The requested rate increase is based on a framework approved by the Ontario Energy Board for the period 2016 to 2020 and is tied to costs for 2017 which include measures to promote efficiency.

#### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Kingston Hydro's request. We will determine whether Kingston Hydro has used the applicable models and formulas as required by the OEB. At the end of this hearing, the OEB will decide on the appropriate rate changes.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process.

- You can review Kingston Hydro's application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply no later than **10 calendar days** after the publication or service date of this notice or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

#### LEARN MORE

These proposed charges relate to Kingston Hydro's distribution services. They make up part of the Delivery line - one of the five line items on your bill. #### WRITTEN HEARING

There are two types of OEB hearings – oral and written. Kingston Hydro has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why.

#### PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
