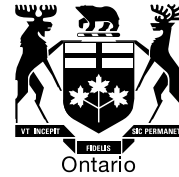

**Re: Hydro One Networks Inc. Transmission Revenue Requirement and Rates
Application 2017 & 2018 - Board File Number: EB-2016-0160
Decision on Confidentiality Request**

In its Decision on Confidentiality Request dated September 21, 2016 the Ontario Energy Board (OEB) ruled on a request by Hydro One for confidential treatment for a number of documents.

The OEB has become aware of a transposition, an omission and a duplication in the Decision that was issued. These errors occurred at the formatting stage of the decision release and are addressed in turn below:

- 1) The second sentence under OEB findings on Page 2, "*With respect to the Outsourcing Agreement, Hydro One stated that portions of the agreement pertaining only to Hydro One's distribution business have been redacted.*", should have appeared at page 3 as the second paragraph under the section addressing attachments 2 and 3.
- 2) A section of text that was entirely omitted, reading: "*OEB staff stated it did not object to the request for confidential treatment on the grounds put forward by Hydro One and SEC did not make any submission with respect to this document.*"

OEB Findings

The OEB grants Hydro One's confidentiality request based on the fact that public disclosure of this information could adversely impact the security and safety of the integrated electric system."

This section of text should have appeared under the discussion of the 4th document at the top of page 4.

3) Finally, a section of text appeared twice. The paragraph that reads,

“OEB Findings

These reports are sold on a subscription fee basis only. The OEB agrees with Hydro One that unrestricted public disclosure of these reports would place CEA at a competitive disadvantage, as potential clients could access the documents free of charge. The OEB grants Hydro One’s confidentiality request for these two documents.”, appears after the consideration of document 5), but was duplicated to appear again as the second paragraph after document 6).

Pursuant to its powers under Rule 41.02 of the OEB’s Rules of Practice and Procedure, the OEB may at any time, without notice or a hearing of any kind, correct a typographical error, error of calculation or similar error made in its orders or decisions.

The OEB has amended the Decision to correct the transposition, add the omission and remove the duplication.

The revised Decision on Confidentiality Request is attached. This revised Decision supersedes and replaces the previously issued Decision.

The revised Decision does not change the OEB’s rulings on the Confidentiality Requests.
