Re: EB-2016-0160 Hydro One Networks Inc. – Update on Motion to Review and Vary Ontario Energy Board (“Board”) Decision on Confidentiality Request

On September 21, 2016, the Board issued its Decision on Confidentiality Request pertaining to, among others, Hydro One’s request for confidential treatment of the following:

- Summary of actual results for Inergi’s performance indicators (PIs), which include the monthly, quarterly and yearly measures, for the period from March 2015 to February 2016 (“**Inergi PIs**”); and
- Inergi Outsourcing Agreement (“**Inergi Agreement**”).

Hydro One advised the Board of its intention to file a notice of motion requesting review and variance of the Decision on Confidentiality Request as it relates to the Inergi Agreement via electronic correspondence on September 21, 2016 (the “**Motion**”). On Day 1 of the Technical Conference (September 22, 2016), Hydro One confirmed its intention to seek the Motion in respect of the Inergi Agreement and potentially in respect of the Inergi PIs.¹

Hydro One is now formally advising the Board of its intention to seek the Motion. The purpose of the Motion will be to seek limited redactions of pricing information, and penalty sanctions that concern the Inergi PIs. Hydro One is not objecting to the disclosure of the Inergi Agreement or the Inergi PIs, except where they affect Hydro One’s ability to negotiate specific monetary measures in future outsourcing contracts, as such disclosure could have potential adverse impacts on ratepayers.


Hydro One intends to file the Motion on or before Friday, September 30, 2016.
