### **Whitby Hydro Electric Corporation**

## Application for electricity distribution rates and other charges effective January 1, 2017

## PROCEDURAL ORDER NO. 1 September 30, 2016

Whitby Hydro Electric Corporation (Whitby Hydro) filed an application with the Ontario Energy Board (OEB) on August 15, 2016 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to its electricity distribution rates to be effective January 1, 2017.

The OEB issued a Notice of Hearing on September 12, 2016. Vulnerable Energy Consumers Coalition (VECC) applied for intervenor status and cost eligibility in relation to Whitby Hydro's request for a refund to customers a balance in a deferral account. No objection was received.

VECC is approved as an intervenor and is eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards* in relation to Whitby Hydro's request outlined above.

The list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

#### IT IS THEREFORE ORDERED THAT:

- 1. OEB staff and VECC shall request any information and material from Whitby Hydro that is in addition to Whitby Hydro's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to VECC by October 7, 2016.
- 2. Whitby Hydro shall file with the OEB complete written responses to the interrogatories and deliver them to VECC by **October 21, 2016.**
- Unless the OEB orders otherwise, any written submission by OEB staff and VECC shall be filed with the OEB and delivered to all other parties by **November** 7, 2016.
- 4. Unless the OEB orders otherwise, Whitby Hydro may file a written reply submission with the OEB, and deliver it to VECC by **November 17, 2016.**

All filings to the OEB must quote the file number, EB-2016-0114 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <a href="https://www.pes.ontarioenergyboard.ca/eservice/">https://www.pes.ontarioenergyboard.ca/eservice/</a>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at

http://www.ontarioenergyboard.ca/OEB/Industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
