Please find enclosed Burlington Hydro Inc.'s amended application seeking authorization to charge:

- Changed rates pursuant to the Board's 4<sup>th</sup> Generation Incentive Rate-making Mechanism;
- Rate riders to dispose of balances recorded in Deferral/Variance Accounts as of December 31, 2015 plus associated Carrying Charges that dispose of the Lost Revenue Adjustment Mechanism – Variance Account ("LRAM-VA"); and
- Changed Retail Transmission Service Rates ("RTSR").

Burlington Hydro proposes that these changes take effect May 1, 2017.

Burlington Hydro is amending its prefiled written evidence and is also filing IndEco Strategic Consulting Inc.'s report on the LRAM-VA. Per the Board's Rules, Burlington Hydro's Table of Changes is also enclosed.
