LETTER OF DIRECTION

Dear Ms. Kenequanash:

**Re: Wataynikaneyap Power LP
Application for a Deferral Account for Development Costs in relation to the
Wataynikaneyap Transmission Project
Ontario Energy Board File Number: EB-2016-0262**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Wataynikaneyap Power LP's application to establish a deferral account. Please note that you must post the Notice on your website as required below **within fourteen days** of the date of this letter. If service is not possible within fourteen days, you must inform the Registrar at Registrar@ontarioenergyboard.ca immediately.

You are directed:

1. To arrange immediately for the posting in a prominent place on Wataynikaneyap Power LP's website, of each of the enclosed English, French, Oji-Cree and Ojibway versions of the Notice, in the exact form accompanying this letter, except:
 - a. For the English version of the Notice, under the sections entitled "**BE INFORMED AND HAVE YOUR SAY**" and "**ORAL VS. WRITTEN HEARINGS**" remove the bold and bracketed words "[insert actual date 10 calendar days from the date the notice is posted on the applicant's website]";
 - b. For the French version of the Notice, under the sections entitled "**SOYEZ RENSEIGNÉ ET DONNEZ VOTRE OPINION**" and "**AUDIENCES ORALES ET AUDIENCES ÉCRITES**" remove the bold and bracketed words "[insérer la date, 10 jours suivant la date de publication sur le site Web du demandeur]";

- c. For the Oji-Cree and Ojibway versions of the Notice, remove the placeholders in the draft notice that indicate that the date that the notice is posted on the applicant's website will be inserted (similar to those provided for in 1(a) and 1(b) above); and
 - d. In each of the English, French, Oji-Cree and Ojibway versions of the Notice, insert the same date which shall be determined by adding 10 calendar days to the date that the Notice will be posted on Wataynikaneyap Power LP's website in accordance with the requirements set out earlier in paragraph 4 of this letter. If that date falls on a "holiday" as defined in Rule 6.02 of the OEB's *Rules of Practice and Procedure*, insert the next date that is not a holiday. Use the following date format "**January 1, 2014**" for the English version of the Notice, "**1 janvier 2014**" for the French Notice and an appropriate format for the Oji-Cree and Ojibway Notices.
2. Once the the requirements of paragraph 1 are completed, to immediately and prior to completing any other steps required in this letter of direction, file with the OEB a pdf version of the complete (dated) Notice (Dated Notice).
 3. To make a copy of the English, French, Oji-Cree and Ojibway versions of the Dated Notice available for public review at Wataynikaneyap Power LP's office.
 4. To make the application and the evidence, and any amendments thereto, available for public review at Wataynikaneyap Power LP's office and in a prominent place on Wataynikaneyap Power LP's website.
 5. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 4 above immediately thereafter.
 6. To provide a copy of the Dated Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.
