**Re: Distributor Gas Supply Planning Consultation – EB-2015-0238
Enbridge Gas Distribution Comments on Intervenor Cost Claim Submission**

In regards to the Ontario Energy Board's (the "Board") Notice of Hearing for Cost Awards for the Distributor Gas Supply Planning Consultation dated October 4, 2016, Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") has reviewed the cost claims received from the Association of Power Producers of Ontario (APPo), Building Owners and Managers Association (BOMA), Canadian Manufacturers & Exporters (CME), Consumers Council of Canada (CCC), Energy Probe, Federation of Rental-housing Providers of Ontario (FRPO), Industrial Gas User's Association (IGUA), London Property Management Association (LPMA), School Energy Coalition (SEC), and Vulnerable Energy Consumer's Coalition (VECC).

Although the Company has no overall objection to the Intervenor Cost Claims we have noted the following items in our review:

- APPo's net cost for the parking disbursement was \$8.85 per receipt;
- BOMA's net cost for the courier disbursement was \$10.89 per receipt;
- CME's total cost for the parking disbursement was \$27.48 per receipts;
- FRPO's total cost for the parking disbursement was \$20 per receipt and that \$5.41 of hotel tax was not claimed for an accommodations receipt; and
- The Company recognized that there were two stakeholder conferences during this proceeding and that the number of hours claimed may be greater than the hours put forward by the Board on the *Statement of Fees Being Claimed* form.

Enbridge reserves the right to make submissions regarding any outstanding intervenor cost submissions which are subsequently received.

The Company awaits the recommendations and or cost awards of the Board with respect to these cost claims.
