I am aware you are not the person responsible to make the decision regarding the electrical service provider for the new Sellick Equipment Limited facility. However, I am in need of your assistance in getting this letter to the decision makers. The OEB needs to understand the impact of the time required to make a decision is having adverse effects on the construction timeline. Not only is it effecting the building itself but, it is causing delays in the commissioning of the Clark Street extension.

Clark Street is required for us to bring in construction and manufacturing equipment into the plant. Since a decision has not been reached and an electrical service provider has not been selected, street lights cannot be installed on Clark Street. Since there are no street lights installed, the street remains blocked off and inaccessible.

The OEB should be looking at the best interest for the user. As far as Sellick Equipment Limited is concerned, we need reliable, economical electrical power, delivered on time. ## Board objectives, electricity

1. (1) The Board, in carrying out its responsibilities under this or any other Act in relation to electricity, shall be guided by the following objectives:

1. To protect the interests of consumers with respect to prices and the adequacy, reliability and quality of electricity service.

2. To promote economic efficiency and cost effectiveness in the generation, transmission, distribution, sale and demand management of electricity and to facilitate the maintenance of a financially viable electricity industry.

We cannot afford the time to wait while a decision is made. We are asking for the board to meet the objectives as stated in the Ontario Energy Board Act. The delays are not just causing harm to Sellick Equipment Limited but, it is also impeding further development in the Collavino Industrial Park.

Please ensure you are acting in accordance with the act, providing us with cost effective, adequate, reliable, quality electricity and delivered on time.
