**Notification of Metered Market Participant Role** 

In the revised, July 28, 2016, Settlement Proposal approved by the Board section 3.4 a) established the expectation that the market participant designation for Retail Transmission Service Rates would be transferred from NPEI to Grimsby Power. Grimsby Power received its Revised Decision and Rate Order September 22, 2016 and subsequently started the meter market participation process through the IESO.

As per the approved settlement proposal, section 3.4 a), the following provision was added to the tariff sheet for the Embedded Distributor.

"The Retail Transmission Service Rates for the Embedded Distributor will not be charged until Grimsby Power Inc. has the market participant designation for Retail Transmission Service Rates. At the date of transfer, and upon notification to the Ontario Energy Board, Grimsby Power Inc. will begin to apply the Retail Transmission Service Rates to the Embedded Distributor rate class."

Grimsby Power is in receipt of a Registration Approval Notification from the IESO confirming that Grimsby Power is taking over the metered market participant roles for the transmission network resources.

Grimsby Power respectfully submits this letter along with the Registration Approval Notification from the IESO as confirmation that Grimsby Power will take over the metered market participant role for the transmission network resources effective November 1, 2016. As such Grimsby Power will be in a position to charge the Embedded Distributor the approved RTSR's effective November 1, 2016.
