Enbridge Gas Distribution Comments on Intervenor Cost Claim Submission**

In regards to the Ontario Energy Board's (the "Board") Notice of Hearing for Cost Awards for the Distributor Gas Supply Planning Consultation dated October 24, 2016, Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") has reviewed the cost claims received from the Association of Major Power Consumers in Ontario (AMPCO), Association of Power Producers of Ontario (APPRO), Building Owners and Managers Association (BOMA), Canadian Manufacturers & Exporters (CME), Consumers Council of Canada (CCC), Environmental Defence, Federation of Rental-housing Providers of Ontario (FRPO), Green Energy Coalition (GEC), Industrial Gas User's Association (IGUA), London Property Management Association (LPMA), Low-Income Energy Network (LIEN), Ontario Association of Physical Plant Administrators (OAPPA), Ontario Greenhouse Vegetable Growers (OGVG), Ontario Sustainable Energy Association (OSEA), School Energy Coalition (SEC), and Vulnerable Energy Consumer's Coalition (VECC).

Although the Company has no overall objection to the Intervenor Cost Claims we have noted the following items in our review:

- BOMA's net cost for the courier disbursement was \$10.89 per receipt; and
- SEC's submitted 25 hours for the Comment, where the OEB had approved up to 24 hours.

Enbridge reserves the right to make submissions regarding any outstanding intervenor cost submissions which are subsequently received.

The Company awaits the recommendations and or cost awards of the Board with respect to these cost claims.
