RE: Request cancellation of Electricity Generation Licence EG-2015-0360 on or about (but no later than) December 31, 2016

Dear Sir or Madam,

Please find this letter in respect of two generation facilities that reached commercial operation earlier this year, Grey Highlands Zero Emission People (10 MW, FIT Reference # FIT-FQX360R), and ZEP Wind Farm Ganaraska (17.6 MW, FIT Reference # FIT-FTFZ53C) (collectively, the "Facilities"). GHG ZEP Wind Corp. is currently a licenced joint-Owner of both facilities, as tabulated below. GHG ZEP Wind Corp. will be transferring its ownership interests (subject to consent of the IESO), as such, this letter is to hereby request that licence EG-2015-0360 be cancelled concurrently with issuance of a license to GHG Wind Development II LP (the transferee).

By means of procedure, in order for the transaction to close, we require consent from the IESO (the FIT contract counterparty) as well as Hydro One Networks Inc. On November 4, 2016, legal counsel acting on behalf of both joint venture parties for the transaction initiated the consent request with IESO. It was requested that the parties select a target date to be included on the consent agreement as the effective date (e.g. December 15, 2016), which would then be the effective license termination date, and effective license date for the transferee's new license.

As of this letter date, the IESO has not initiated the consent process or confirmed a target effective date. We are hopeful that this process will still conclude before the December holiday season. To provide flexibility, I propose that the effective termination date by December 31, 2016. Representatives of the Owner-Operator would be able to provide a more firm date likely in the next week or two. Please advise if this would be an acceptable approach.
