Hydro One Networks Inc. Application request to Amend Electricity Distribution License ED-2002-0539 and Cancel Distribution Licenses ED-2002-0521, ED-2002-0539, ED-2003-0011

Hydro One Networks Inc. (Hydro One) is applying under Section 74(1)(b) of the *Ontario Energy Board Act, 1998* to amend its Distribution Licence (ED-2003-0043) and under Section 77(5) to cancel Distribution Licenses ED-2002-0521, ED-2002-0539, and ED-2003-0011.

Background

On July 3, 2014, the OEB approved the acquisition by Hydro One Inc. of all of the issued and outstanding shares of Norfolk Power Inc. and the subsequent transfer of Norfolk Power Distribution Inc.'s (NPDI) electricity distribution system to Hydro One. On September 8, 2015 the OEB transferred NPDI's Distribution Licence, ED-2002-0521, to Hydro One.

On March 12, 2015, the OEB approved the acquisition by Hydro One Inc. of all of the issued and outstanding shares of Haldimand County Utilities Inc., and the disposition of its distribution system to Hydro One. On September 12, 2016 the OEB transferred Haldimand County Hydro Inc.'s Distribution Licence, ED-2002-0539, to Hydro One.

On September 11, 2015 the OEB approved the acquisition by Hydro One in of all of issued and outstanding shares of Woodstock Hydro Holdings Inc., and the disposition of its distribution system to Hydro One. On September 12, 2016 the OEB transferred Woodstock Hydro Services Inc.'s licence, ED-2003-0011, to Hydro One.

All three of these distribution companies are now fully integrated into Hydro One.

Request

Hydro One is applying to the OEB, to amend its Electricity Distribution Licence ED-2003-0043, to include the areas served by the above-mentioned three licences.

Hydro One requests the following municipalities be included in Appendix B – Tab 1 of its Distribution Licence:

Name of Municipality: **The Corporation of Haldimand County as defined in the Town of Haldimand Act, 1999**

Formerly Known As: Town of Dunnville, City/ Dunnville, Town of Haldimand, City of Nanticoke (easterly ‘half’ only), as at December 31, 2000.

Name of Municipality: **The Corporation of Norfolk County**

Formerly Known as: Township of Norfolk, Township of Delhi, Town of Simcoe, City of Nanticoke (westerly ‘half’ only), as at December 31, 2000.

Name of Municipality: **The City of Woodstock, as of September 1, 1997.**

Formerly Known as: Same

Hydro One requests that the following sections be removed from Appendix B, Tab 4 of its Distribution Licence.

Name of Municipality: **The Corporation of Norfolk County**

Formerly Known As: Township of Norfolk, Township of Delhi, Town of Simcoe, City of Nanticoke (westerly ‘half’ only), as at December 31, 2000.

Area Not Served By Networks: The area served by Norfolk Power Distribution Inc. described as the former Town of Delhi (in the former Township of Delhi), the westerly half of the former City of Nanticoke, the former Village of Port Rowan (in former Township of Norfolk), and the former Town of Simcoe as more particularly set out in Licence No. ED-2002-0521.

Networks assets within area not served by Networks: Yes

Customer(s) within area not served by Networks: One Industrial customer located at Lake Erie and Regional Rd.. 3, Nanticoke, ON.

Name of Municipality: **City of Woodstock as at March 31, 1999.**

Formerly Known As: Same

Area Not Served By Networks: The area served by Woodstock Hydro Services Inc. described as the City of Woodstock as more particularly set out in Licence No. ED-2003-0011, including the Boot Hill Development located on part of lots 3, 7, 8, 11, 12, 13 and registered plan 86 and 501, and three customers on Mill Street with civic address numbers 388, 390 and 410.
