Re: EB-2016-0073 Grimsby Power Incorporated – 2017 IRM Electricity Distribution Rate Application for 2017 Rates

Grimsby Power has reviewed Board Staff's Draft Decision and Rate Order issued December 7, 2016 in respect of the above noted file. Grimsby Power agrees with all tariffs of rates outlined in the draft Tariff of Rates and Charges shown in Schedule A of the Draft Decision and Rate Order.

Grimsby Power does note, however, that in Board Staff's Rate Generator model dated November 22, 2016 (Grimsby_2017_IRM_RateGen_Model_BS_20161122) the "Total Deferral/Variance Account Rate Riders" for the GS>50 to 4,999 kW rate class on tab 20 bill impacts is incorrect. The amount shown in Board Staff's Rate Generator model includes the Rate Rider for Disposition of Deferral/Variance Accounts (2016) for the Non-Wholesale Market Participant (WMP) and the WMP. The Total Deferral/Variance Account Rate Riders for the GS>50 to 4,999 rate class reflected in the bill impacts tab should only include the Deferral/Variance Rate Rider (2016) for the Non-WMP, not both (2016) rate riders. As in the original submission Grimsby Power has made a manual adjustment to remove the (2016) rate rider intended only for WMP from the Total Deferral/Variance Account Rate Riders in the bill impacts tab for the GS>50 to 4,999 rate class. This adjustment reduces the bill impacts for the rate class slightly. Further details on the calculation of the manually adjusted Total Deferral/Variance Account Rate Riders can be found on pages 18 and 19 of 27 in the original 2017 IRM submission.

Grimsby Power also notes that in Schedule A, Tariff of Rates and Charges, for the General Service 50 to 4,999 kW service classification the amount of 0.2304 \$/kW

should be identified as "Rate Rider for Disposition of Deferral/Variance Accounts (2017) - effective until December 31, 2017". This rate rider would apply to all customers including the WMP.
