Dear Ontario Energy Board Secretary,

Unified Energy is requesting our original Ontario Energy License application to be amended. Unfortunately, there was an oversight on our behalf when filing and an incorrect box was elected. We inadvertently selected the wrong box under Sec 9. a). Page 7 - "Intended Services and Markets" on our application.

The incorrect box that was elected shows we sell or offer to sell electricity to large volume consumers in Ontario. See below print screen with the X in the red box. However, we are not a large volume consumer only company and we NEVER take ownership or title to electricity as we act as a broker or agent.

We are requesting we amend our License to reflect that we would like to elect the other two boxes shown below in the red rectangles under Section 9. a). Page 7 - "Intended Services and Markets" on our application.

## 9. Intended Services and Markets

(a) Intended Services: please identify which of the following services the applicant intends to offer. You may select as many as applicable.

- to sell or offer to sell electricity to low-volume consumers (annually consuming less than 150,000 kilowatt hours of electricity) in Ontario.
- to sell or offer to sell electricity to large-volume consumers (annually consuming more than 150,000 kilowatt hours of electricity) in Ontario.
- to act as an agent or broker for a retailer with respect to the sale or offering for sale of electricity to large-volume consumers, or as an agent or broker for large-volume consumers with respect to the sale or offering for sale of electricity in Ontario.
- to act as an agent or broker for a retailer with respect to the sale or offering for sale of electricity to low-volume consumers, or as an agent or broker for low-volume consumers with respect to the sale or offering for sale of electricity in Ontario.

To confirm, we would like to elect the above two boxes referred as:

"To act as an agent or broker with respect to the sales or offering for sale of electricity to large-volume consumers, or as an agent or broker for large-volume consumers with respect to the sale or offering for sale of electricity in Ontario."

“To act as an agent or broker with respect to the sales or offering for sale of electricity to low-volume consumers, or as an agent or broker for low-volume consumers with respect to the sale or offering for sale of electricity in Ontario.”

Since we have not been acting or performing any responsibilities elected on our initial application, “to sell or offer to sell electricity to large-volume consumers”, we are requesting that you acknowledge and accept our revision to our initial application which was approved on 3/17/2016.
