Written Submission of the Ministry of Natural Resources and Forestry

Introduction:

Union Gas Limited (Union) applied on November 4, 2016 to the Ontario Energy Board (OEB) for approvals that will allow Union to increase capacity and deliverability of two natural gas designated storage pools located in the Township of Dawn-Euphemia in Lambton County:

- A vary order request to allow Union to increase the operating pressures in its Dawn 156 natural gas storage pool above the current operating pressures approved by the OEB in EB-2007-0633 proceeding;
- 2. A favourable report to the Ministry of Natural Resources and Forestry (MNRF) pursuant to section 40(1) of the *Ontario Energy Board Act, 1998* for licences to drill three injection/withdrawal (I/W) wells in Dawn 156 pool and one I/W well in Bentpath pool, deepen and convert an observation well to an I/W well and depen three I/W wells in the Bentpath pool; and
- 3. Leave to construct a 600 metre, 12 inch nominal diameter pipeline within the Dawn 156 and Bentpath pools, pursuant to section 90 of the *Ontario Energy Board Act*, 1998

On December 1, 2016 the MNRF referred to the Ontario Energy Board Union's applications to drill the above-noted wells.

The OEB subsequently initiated this proceeding through a formal Notice on December 15, 2016 and the release of Procedural Order No. 1 on January 10, 2017.

Further to Interrogatories and responses to Interrogatories, here now are the Written Submissions of the MNRF.

Analysis

With reference to the MNRF Interrogatories, MNRF is satisfied that Union has

offered a complete response.

MNRF reminds Union that, as the operator, it bears the responsibility for ensuring that there is adequate cap rock to support the additional delta pressure and that all safety and environmental issues have been addressed.

With reference to the Board Staff Interrogatories relating to pool studies, risk analysis, and compliance with CSA Z341 Storage of Hydrocarbons in Underground Formations, MNRF acknowledges that it has received the reports as indicated in Union's response to Board Interrogatory 4a (i.e., HAZOP, Assessment of Neighbouring Activities, and Engineering Assessment reports for each of the Dawn 156 Pool and the Bentpath Pool). MNRF is satisfied that these reports are complete.

MNRF reminds Union that, as the operator, it bears the responsibility for compliance with the *Oil, Gas and Salt Resources Act*, O.Reg. 245/97, the Provincial Standards and CSA Z341: Storage of Hydrocarbons in Underground Formations.

With respect to the Board Staff Draft Proposed Conditions of Approval and the Board Staff Draft Leave to Construct Conditions of Approval, as found in the Board Staff Interrogatories 11 and 12 respectively, MNRF has no objections to these proposed conditions.

Conclusion and Relief Requested:

In conclusion, MNRF has no objection to approval of the application as proposed.
