# Enbridge Gas Distribution Inc.

# Application for approval to drill one injection/withdrawal well in the Corunna designated storage area in the Township of St. Clair in Lambton County

#### PROCEDURAL ORDER NO. 1 March 6, 2017

Enbridge Gas Distribution Inc. (Enbridge Gas) filed an application dated December 20, 2016 with the Ministry of Natural Resources and Forestry (MNRF) for one well drilling licence in the Corunna designated storage area. The application was referred to the Ontario Energy Board (OEB) by the MNRF on November 28, 2016, pursuant to section 40 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (schedule B).

A Notice was issued on February 7, 2017 and was served and published as directed.

Union Gas Limited (Union Gas) and the MNRF applied for intervenor status. Enbridge did not file any objection.

Intervenor status is hereby granted to Union and the MNRF. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

### IT IS THEREFORE ORDERED THAT:

1. If OEB staff, Union Gas or the MNRF require information and material from Enbridge Gas that is in addition to Enbridge Gas' evidence and that is relevant to the hearing, OEB staff shall request it by written interrogatories filed with the OEB and delivered to Enbridge Gas by **March 13, 2017**.

- 2. Enbridge Gas shall file with the OEB complete responses to the interrogatories by **March 20, 2017**.
- 3. Unless the OEB orders otherwise, OEB staff, Union Gas and the MNRF may file any written submission with the OEB and deliver it to Enbridge by **March 29, 2017**.
- 4. Unless the OEB orders otherwise, Enbridge Gas may file a written reply submission with the OEB by **April 7, 2017**.

All filings to the OEB must quote the file number, EB-2016-0378 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <a href="https://www.pes.ontarioenergyboard.ca/eservice/">https://www.pes.ontarioenergyboard.ca/eservice/</a>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
