## Electricity Transmission Company B2M LP has applied to change Ontario's electricity transmission rates.

B2M Limited Partnership has applied to the Ontario Energy Board to increase the amount of revenue it will earn for 2017. If its application is approved it would have a minimal impact on the monthly cost of electricity for an average residential customer.

The Ontario Energy Board's decision on this application will have an effect on all electricity consumers in Ontario. The cost of transmission is reflected in the delivery charges included on bills.

## THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider B2M's request. We will question the company on its case for a rate increase. We will also hear arguments from individuals and from groups that represent B2M's customers. At the end of this hearing, the OEB will decide what, if any, change will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process.

- You can review B2M's application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **March 20, 2017** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

### PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
