The Ontario Energy Board (OEB) received Niagara-on-the-Lake Hydro Inc. and Alectra Utilites Corporation's application for Elimination of Load Transfer Arrangements on February 16, 2017. The OEB has assigned file number EB-2017-0096 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.
