This letter confirms and serves as formal notice to the Ontario Energy Board that, effective as of March 31, 2017 our company, Commerce Energy, Inc. ("Commerce Energy"), will be changing its company name to Just Energy Solutions Inc. ("Just Energy").

We are changing our company name to establish brand recognition for the Just Energy name. This change does not result in a material change as it is simply just a name change. We will maintain the same Tax ID, Dunn and Bradstreet number, organizational structure, operational functions, business contacts, directors and/or officers, address and all and agreements will remain the same, with minor updates where needed. As there will be no customers impacted, notification will not be required.

Please be advised that there are registrations in place with the National Energy Board, Independent Electric System Operator, and New York Independent System Operator that will be effected by the company name change, in turn, we are hoping to have the name change completed with all effected parties on March 31, 2017.

Documentation supporting the name change will be available after March 31, 2017 and will be provided to the OEB upon receipt.


Organizational Structure

Description of the Corporate Structure

Commerce Energy, Inc. is a California Corporation and an indirect subsidiary of Just Energy Group Inc. ("Just Energy") a corporation established under the laws of Canada. Just Energy is a publicly traded corporation (NYSE:JE and TSX: JE).

Organizational Structure of the Company

The following diagram sets forth the simplified organizational structure of the Company.



Notes:

- The Canadian Subsidiaries are corporations, limited partnerships, and unlimited liability companies directly or indirectly wholly-owned by the Company. The Canadian operating Subsidiaries are Just Energy Ontario L.P. (Ontario); Just Energy Alberta L.P. (Alberta); Just Green L.P. (Alberta); Just Energy Manitoba L.P. (Manitoba); Just Energy (B.C.) Limited Partnership (British Columbia); Just Energy Québec L.P. (Quebec); Just Energy Prairies L.P. (Manitoba); Just Energy Trading L.P. (Ontario); and Hudson Energy Canada Corp. (Canada). Just Energy Corp. is the general partner of each of the Canadian operating limited partnerships. Additionally, the Company indirectly holds an approximate 10% fully diluted interest in ecobee Inc., a manufacturer and distributor of smart thermostats located in Toronto, Ontario.
- The U.S. Subsidiaries are corporations, limited liability companies and limited partnerships indirectly wholly-owned by the Company and are incorporated or formed, as applicable, under the laws of the State of Delaware, unless otherwise noted. The U.S. operating Subsidiaries are Just Energy (U.S.) Corp.; Just Energy Illinois Corp.; Just Energy Indiana Corp.; Just Energy Massachusetts Corp.; Just Energy New York Corp.; Just Energy Texas I Corp.; Just Energy Texas LP (Texas); Just Energy Pennsylvania Corp.; Just Energy

Marketing Corp.; Just Energy Michigan Corp.; Hudson Energy Services LLC (New Jersey); Just Energy Limited; Fulcrum Retail Energy LLC (Texas); Tara Energy, LLC (Texas); and Just Solar Holdings Corp.

Hudson Energy Holdings UK Limited and Hudson Energy Supply UK Limited are direct and indirect wholly owned subsidiaries of the Company operating in the United Kingdom. Just Insurance Limited, a Barbadian company, an indirect wholly owned subsidiary of the Company, provides self-insurance to the Company and its subsidiaries. Just Energy Germany GmbH is an indirect wholly owned subsidiary of the Company, operating in Germany. Just Energy (Ireland) Limited is an indirect wholly owned subsidiary of the Company, operating in Ireland.
