**Hydro One Sault Ste. Marie LLP**

**Application for electricity transmission revenue  
requirement effective January 1, 2017**

**PROCEDURAL ORDER NO. 1**

**March 29, 2017**

Hydro One Sault Ste. Marie LLP (Hydro One SSM) filed an application with the Ontario Energy Board (OEB) on December 28, 2016 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Electricity Transmission Applications, seeking approval for changes to its electricity transmission revenue requirement to be effective January 1, 2017.

The OEB issued a Notice of Hearing on March 13, 2017. The Vulnerable Energy Consumers Coalition (VECC), Schools Energy Coalition (SEC) and the Association of Major Power Consumers of Ontario (AMPCO) applied for intervenor status and cost eligibility in relation to Hydro One SSM's request for a revenue cap index consisting of inflation of 1.9%, adjusted by productivity and stretch factors of 0%. No objection was received.

VECC, SEC and AMPCO are granted intervenor status and are eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards* in relation to Hydro One SSM's request outlined above.

The list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff and intervenors shall request any information and material from Hydro One SSM that is in addition to Hydro One SSM's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Hydro One SSM and all other parties by **April 13, 2017**.
2. Hydro One SSM shall file with the OEB complete written responses to the interrogatories and deliver them to intervenors by **May 4, 2017**.

All filings to the OEB must quote the file number, EB-2016-0356 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
