Application for electricity transmission revenue requirement effective January 1, 2017

PROCEDURAL ORDER NO. 1 March 30, 2017

B2M Limited Partnership (B2M LP) filed an application with the Ontario Energy Board (OEB) on December 1, 2016 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Electricity Transmission Applications, seeking approval for changes to its electricity transmission revenue requirement to be effective January 1, 2017.

The OEB issued a Notice of Hearing on February 27, 2017. The Society of Energy Professionals (the Society) applied for intervenor status in relation to B2M LP's application. No objection was received.

The Society is granted intervenor status in relation to B2M LP's application.

The list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- OEB staff and the intervenor shall request any information and material from B2M LP that is in addition to B2M LP's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to B2M LP and all other parties by April 10, 2017.
- 2. B2M LP shall file with the OEB complete written responses to the interrogatories and deliver them to the intervenor by **April 27, 2017.**
