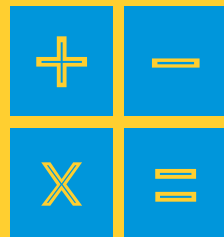

Understanding the Price Comparison

This Price Comparison compares the price consumers in the northeastern part of Ontario pay for the natural gas commodity, transportation and storage bought from Union Gas Ltd. (Union Gas) (Table A) to the contract price offered by the energy retailer (Table B). Table B also shows whether transportation and/or storage is included in the contract price offer. This is not a total bill comparison.

Even if you switch to an energy retailer, you will still have to pay other charges every month to have your natural gas delivered to your home by Union Gas. These charges include delivery and customer charges, as well as taxes.

The information in Table B and the “Description of Contract Price Offer” was prepared by the energy retailer. Table A and all other information was prepared by the Ontario Energy Board (OEB).



Use The OEB’s Online Bill Calculator To Compare Prices

Before you enter into an energy contract, get a current price comparison. Use your own utility bill, the contract price offer and the OEB’s bill calculator.

Go to OEB.ca

Table A shows the natural gas, transportation and storage prices set by the OEB and charged by Union Gas. The natural gas price is affected by the market price of natural gas and can change every 3 months. Table B shows the contract price for natural gas offered by the energy retailer, and whether you will be paying a contract price for transportation and/or storage or the price charged by Union Gas.

The energy usage shown represents natural gas usage for one month based on how much a typical household uses in a year. Because natural gas use changes throughout the year, your actual monthly use will likely be different.
