In the Rate Order dated April 13, 2017, the Ontario Energy Board approved Atikokan Hydro's Tariff of Rates and Charges with an implementation date of May 1, 2017.

Atikokan Hydro has reviewed the Decision and Order and is writing to inform the OEB some mistakes noted on the Tariff of Rates and Charges.

The General Service 50 to 4,999 KW shows an end date of April 30, 2019 for the Rate Rider for Group 2 Accounts but should read April 30, 2018. These dispositions were approved for one year.

Street Lighting shows an end date of April 30, 2019 for the Rate Rider for Group 2 Accounts but should read April 30, 2018. These dispositions were approved for one year.

For the Street Lighting Service Classification, the incorrect allocator is listed on the Tariff for the following lines.
