- I, JOHN C. HUNTER, of the Township of Dover, in the County of Kent, make oath and say as follows:
- 1. I am Vice-President, Gas Supply of Union Gas Limited and as such have knowledge of the matters hereinafter deposed to.
- 2. The Storage Development Task Force Report (the "Report"), which is the subject matter of this appeal, was prepared in or about April 1987 at my direction.
- 3. The Report was prepared as an internal document for the purpose of analyzing and reporting Union Gas Limited's long term gas storage development and acquisition strategy for gas storage facilities.

- 4. The Report sets out how Union proposes to meet its gas storage requirements and includes information on Union's existing gas storage facilities and gas storage pools available for acquisition in Ontario, the anticipated development costs associated with those pools, development sequences and strategy, Union's assessment of the relative value of the pools, and provides an indication of what Union Gas should be prepared to pay to acquire those pools.
- 5. The Report is an internal document of Union Gas and is highly confidential. In my opinion, if the contents of this report are made known to Union Gas' competitors, directly or indirectly, then Union Gas' efforts to acquire and develop gas storage facilities will be seriously prejudiced.
- 6. Furthermore, should the current owners of the pools referred to in the Report become aware of what Union Gas is prepared to pay to acquire their pools, then Union Gas will have been seriously prejudiced if it tries to negotiate the lowest possible purchase price. Any additional costs expended to acquire gas storage facilities will ultimately be paid for by the gas consumers of Ontario and Quebec through Union's rates.
