**B2M Limited Partnership**

**Application for electricity transmission revenue  
requirement effective January 1, 2017**

**PROCEDURAL ORDER NO. 2**

**May 8, 2017**

B2M Limited Partnership (B2M LP) filed an application with the Ontario Energy Board (OEB) on December 1, 2016 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's *Filing Requirements for Electricity Transmission Applications*, seeking approval for changes to its electricity transmission revenue requirement to be effective January 1, 2017.

The OEB issued a Notice of Hearing on February 27, 2017. The Society of Energy Professionals (the Society) was granted intervenor status in relation to B2M LP's application.

The OEB issued Procedural Order No. 1 on March 30, 2017, setting dates for interrogatories to B2M LP. OEB staff filed written interrogatories with the OEB on April 10, 2017. The Society did not file interrogatories. B2M LP filed written responses to the OEB staff interrogatories on April 26, 2017.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall file its written submission with the OEB and serve it on the applicant by **May 19, 2017**. The Society shall also file its written submission, if any, with the OEB and serve it on the applicant by the same date.
2. B2M LP shall file its reply submission, if any, with the OEB and serve it on the Society and OEB staff by **May 30, 2017**.

All filings to the OEB must quote the file number, EB-2016-0349 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
