

**LETTER OF DIRECTION**

Dear Mr. Packer:

**Re: Union Gas Limited - 2008 Rates – Notice of Applications and Combined  
Proceeding  
Board File Nos. EB-2007-0606 (Union) and EB-2007-0615 (Enbridge)**

The Board has now issued the enclosed Notice of Applications ("Notice") in the above matter.

You are directed:

1. to immediately serve a copy of the Notice in both the English and French versions, together with a copy of the Application, either personally, by courier, or by registered mail on the Clerks of all municipalities in which Union Gas supplies gas, and the English version only, together with a copy of the Application, on all Native Bands and Native Reservations to which Union Gas supplies gas, on all intervenors in EB-2005-0520, on Enbridge Gas Distribution Inc., on Natural Resource Gas Limited and on the Norfolk Federation of Agriculture;
2. to immediately arrange for the English version of the Notice, headed with the Ontario Government logo and the words "Ontario Energy Board", to be published in one issue of English-language daily newspapers and one issue of English language weekly newspapers having the highest circulation, according to the best information available, throughout Union Gas' service areas;
3. to immediately arrange for the French version of the Notice, headed with the Ontario Government logo and the words "Commission de l'énergie de

l'Ontario", to be published in one issue of any French daily newspaper, if available, and one issue of all weekly French language newspapers throughout Union Gas' service areas;

**NOTE:** Please make it clear to the newspaper that any invoices regarding publication are to be sent to the Applicant not to the Board.

4. to file with the Board affidavit evidence proving the above service and publication immediately upon completion, attaching as appendices the relevant Notice, Application, and original post office registration or courier receipts, but not the newspaper tear sheets;
5. to ensure that complete copies of the Application and the prefilled evidence are available for convenient public perusal at the head office of Union Gas;
6. to immediately provide a copy of the Application to any person upon request; and
7. to immediately supply a copy of the prefilled evidence to any person upon request.

**NOTE:** It is understood that the evidence related to this proceeding will be filed in due course
